Contractual Agreement

Article I.

Purpose of this Contract

1. The purpose of this contract is to provide a financial donation of 563,060 CZK (five hundred sixty-three thousand sixty Czech Crowns) to aid in the reconstruction of the ZOO following a tornado (referred to as the "Gift").
2. The monetary contribution was made via wire transfer to the above-mentioned Donee's bank account number CZ780100000000001122122. The financial Gift is given solely for the Donee's needs and not for the needs of any other person or party.
3. The Gift is accepted by the Donee.

Article II.

Rights and Obligations

1. When the financial Gift amount is deposited into the Donee's bank account, the Gift becomes the property of the Donee.
2. By accepting the financial Gift, the Donee agrees to no other obligations towards the Donor now or in the future.

**Article III.
Final Provisions**

1. Only by consent of the contractual parties and in the form of written, numbered amendments may the contract be supplemented or altered.
2. This contract will come into effect on the date that both contracting parties sign it and terminates on 5 September 2021.
3. The contracting parties shall acknowledge by their signatures that they have read and agree with the contract's wording, and that the contract was signed voluntarily.
4. The Czech Republic's competent legislation governs this contract. Any resulting issues will be determined by the Czech Republic's proper courts.
5. This contract shall be written in two identical copies, one of which shall be received by each contracting party and shall have the same validity as the original.
