- 2. The Animals will be transported by 31.8.2021.
- **3.** The Vogelpark Turnersee confirms that it is the owner of the Animals.
- **4.** The Recipient is required to cover all transport costs.
- 5. The Animals will belong to the Recipient after delivery.
- **6.** The Vogelpark Turnersee provides no warranty as to the health of the Animals. The Vogelpark Turnersee assures that it is not aware of the Animal's having not any diseases or contagious diseases. The Animals will be delivered in a good state of health, without any clinical symptoms of disease.
- 7. The Animals will be delivered with a valid Certificate of Health and Origin and other documents respecting all requirements given by the exporting country and by the importing country as reported by the Recipient (see Point 7).
- **8.** The Recipient is required to ensure the Animals with adequate housing, diet, veterinary care and other necessities conducive to the well-being of the Animals.
- 9. Two identical copies of this agreement are executed, one for each Party.



- **10.** Any difference or dispute arising out of the interpretation and/or implementation of this agreement shall be settled amicably through consultation and/or negotiations between the parties.
- **11.** The Contracting Parties agree with publication of this agreement in its entirety including personal data contained in the contract, as well as of the acts and circumstances associated with this agreement, or with provision of information to third parties about this agreement or the essential parts of this agreement, under the conditions defined in Act No. 106/1999, free access to information, in the version current at the date of request for information or publication, and also declare that none of the contents of the contract shall be considered as trade secret.
- 12. Rights and obligations of the parties that are not explicitly defined in this agreement shall be governed by relevant provision of the Civil Code of the Czech Republic. While this Agreement has been executed in English, it is subject to the laws of the Czech Republic only.
