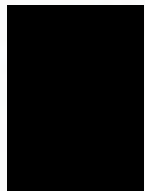

RECITALS

- A Endemol Shine International Limited ("ESI") and the Licensee entered an agreement relating to the marketing, sale and distribution of [REDACTED] and [REDACTED] (the "Principal Agreement").
- B Following the acquisition of ESI by Banijay, Banijay and the Licensee signed a Novation Agreement on 26 August 2021 (with effect from 1 October 2020) whereby Banijay acquired all rights, liabilities, title, interest and benefits of ESI under the Principal Agreement.
- C It is agreed between the parties that the Principal Agreement is now to be amended.
- D In consideration of the mutual exchange of the sum of £1.00 (receipt and sufficiency of which is hereby acknowledged) the parties agree to vary and amend the Principal Agreement on the terms of this Agreement.

IT IS AGREED AS FOLLOWS

1 INTERPRETATION

Unless the way a word or phrase is used suggests a different meaning:

- (a) expressions appearing in this Agreement and in the Principal Agreement have the meanings ascribed to them in the Principal Agreement; and
- (b) this Agreement is interpreted according to the terms of the Principal Agreement.

2 AMENDMENTS



The Principal Agreement is amended as follows:

- (i) Owing to the delay of the world premiere of the Title [REDACTED] at the Licensee's request, all rights granted under the Principal Agreement in relation to the Title [REDACTED] are hereby revoked and all references to this Title in the Principal Agreement are intentionally deleted.
- (ii) Following signature of this Agreement, Banijay shall issue the Licensee a refund to the Licensee's bank account in respect of the Title [REDACTED]

3 PRINCIPAL AGREEMENT

Except and to the extent only of the variations and amendments contained in this Agreement, the Principal Agreement remains in full force and effect and the parties agree to continue to be bound by the Principal Agreement.

4 CONSENTS

The parties represent to each other that all consents required to amend or vary the Principal Agreement have been obtained.

5 COSTS

Each party must meet its own costs of preparation of this Agreement.

6 AMENDMENT

The parties may amend this Agreement only by another document executed by the parties.

7 GOVERNING LAW

The laws in force in England and Wales govern this Agreement.
