PřF started preparational works by signing contract of cooperation with C-IN company. This caused functionally expended costs of 8942 EUR, which cannot be covered from the conference fees.

ESMR is willing to financially support PŘF and undertakes to assume part of this cost, in total amount of 3286 EUR, from PŘF. This part of the debt will be settled upon invoice issued by the creditor with 30 days due period.

C-IN agrees that 3286 EUR out of the expended costs will be covered by ESMR.

The way of covering the remaining costs of 5656 EUR will be settled by the separate contractual agreement between C-IN and PŘF.

This agreement becomes valid once being signed by all the parties and becomes effective upon publication in the contract register according to the law 340/2015 Sb.
