1. The Publisher shall publish the work with the title:
Ritualising Heritage, Re-enchanting Rituals
Late-modern Transformations of 'Tradition' in Europe
within European Studies in Culture and Policy Series of its publishing program.

The author of the work is Dr. Alessandro Testa. The property copyright of work is exercised by FSV UK.

2. The FSV UK shall pay the Publisher € 4.000,00. The first 50 % of the amount shall be paid with the submission of the manuscript and the second 50 % shall be paid when the production of the book has been completed.
3. The FSV UK shall provide a manuscript ready for type-setting work according to the house style of the Publisher.
4. Length: 250 pages, Binding: hardcover - sewn binding, First print-run: 250 copies, Format: A5 (21x14,7)
5. The FSV UK shall be charged for all author's corrections.
6. The FSV UK shall receive 30 copies. The copies will be dispatched at the FSV UK's risk and expense. The FSV UK may purchase additional copies with a 40 % discount.
7. The FSV UK hereby warrants to the Publisher that he controls all copyrights related to the work. The FSV UK hereby transfers completely all copyrights related to the work including the rights for electronic forms of publication for all editions to the Publisher.
The Publisher shall administer the Publishing Law not in a restrictive manner but allow the Author to disseminate his views also in other contexts. The Author and TSV UK may for instance use parts of the work in essays provided she quotes the original source correctly. On Open Access edition shall be available 24 month after the publication date of the print edition.
8. The retail price shall be € 34,90.
9. The FSV UK and the author shall receive no royalties.
10. In addition this agreement shall be governed by and construed in accordance with the Swiss Publishing Law (Schweizer Verlagsrecht).
11. Place of jurisdiction and fulfilment (Gerichts- und Erfüllungsort) is Zürich / Switzerland.
12. Both parties are aware of the fact that this agreement will be published in the registry of the contracts pursuant to Act No. 340/2015 Coll., on Registry of Contracts and parties agree with this publication. The publication of this agreement will be arranged by FSV UK within 30 days after the day of its signature. This agreement shall enter effect from the day following its publication in the Central Register of Contracts. FSV UK shall give The Publisher a notice of such publication and shall at the same time submit proof of that publication and its date.
