HAVING REGARD to the specific contract SC01 ('the specific contract') implementing F-SE-17-T11-C08-L03 ('the contract') concluded between the contracting authority and the contractor on 15/01/2021,

WHEREAS the contracting authority has informed the contractor about the necessity to include additional services;

WHEREAS the contractor has informed the contracting authority that the requested additional services, as described in Annex I of this amendment, represent an additional cost of EUR 550 as per the contractor's financial offer in Annex II of this amendment;

WHEREAS the value of the modification does not alter the subject matter of the initial specific contract and is in line with Article 172.3(c) of the Financial Regulation;

WHEREAS the aforementioned change needs to be formalised in an amendment to contract;

HAVE AGREED

Article 1





Article 4.1 is replaced by the following:

The maximum total price to be paid under this specific contract shall be EUR 47,550 covering all tasks executed.

Article 2

The Annex III of the specific contract (task acceptance form) is replaced by Annex III of this amendment.

Article 3

The present amendment shall form an integral part of the specific contract and it shall enter into force after signature by the last contracting party.

Article 4

All other provisions of the specific contract shall remain unchanged and shall continue to apply for the period of performance indicated in Article 2.2 of the specific contract.


