

Amendment No. 1 to the “Double Degree Agreement” of 19 October 2020 (hereinafter referred to as “Agreement”) concerning the Realization of a Joint Study Programme of Political Science

University of Hradec Králové (hereinafter referred to as “UHK”) with legal domicile at Rokitanského 62/26, 500 03 Hradec Králové, Czech Republic, represented in this Agreement by XXXXXXXXXXXXXXXXXXXXXXXXXXXX

and

Pontificia Universidad Javeriana Cali (hereinafter referred to as “PUJ Cali”), having its registered office at Calle 18 No. 118-250 Cali, Colombia, represented in this Agreement by XXXXXXXXXXXXXXXXXXXXXXXXXXXX

taking into consideration:

- the FF UHK (as it is defined in the Agreement) has recently acquired new accreditation of the study programme Political science,

hereby agree to the following amendment to the Contract (hereinafter referred to as “Amendment”):

Article 1

Basic Objectives of Agreement

1. According to the fact, that the FF UHK has acquired new accreditation of the study programme Political science, and this new accreditation stands alongside the original accreditation presumed by the Agreement, the contracting parties declare that the Agreement shall govern both accreditations of FF UHK. Due to the fact that the new accreditation slightly differs from the original one, the contracting parties amend the Agreement by attachments No. 1a and 2a which shall govern rights and obligations of students enrolled in the joint study programme under the new accreditation. The text of Attachment 1 and 2 of this Amendment forms Attachment 1a and 2a to the Agreement.
2. Contracting parties hereby agree that the students enrolled in the joint study programme under the original accreditation shall be governed by the provisions stipulated in the Attachment 1 and 2 to the contract. The students enrolled in the joint study programme under the new accreditation shall be governed by the provisions stipulated in the Attachment 1a and 2a to the Contract.

3. The other provisions of the Agreement remain unchanged.

Article 2

Final Provisions

- 1. This Amendment comes into force and takes effect on the date of signing thereof by both the parties.
- 2. This Amendment is executed in four original copies written in English, all of which shall be equally valid, and each of the parties shall receive two copies thereof.
- 3. The decisive language is English.
- 4. The parties declare that they have read this Amendment prior to its signing, they have understood its contents and it has been concluded after mutual negotiations according to the parties’ true and free will, seriously and comprehensibly, without any errors and not in distress or under conspicuously unfavourable conditions, and as a sign of their consent with the contents thereof they have voluntarily signed it in their own hand.
