I am sorry to let you know that the above-mentioned application has become abandoned at the USPTO. We received a Non-Final Office Action from the USPTO in March, but through an administrative failure, the Office Action and the respective deadline was not entered into our calendaring system. I can revive the application instantly on-line by paying the revival fee and filing a response to the Office Action.
