1. Introductory provisions

- 1.1. The Supplier and the CzDA have entered into the Contract on provision of services no. 280188/2021-ČRA signed on 23 March 2021 (hereinafter "Contract"). In the Contract, the Supplier has undertaken to carry out activities primarily aimed towards supporting the functioning and operation of the cooperative "Cincar" Livno (hereinafter "Cooperative").
- 1.2. The purpose of this Amendment no. 1 is the adjustment of the implementation period of the project. Due to the inactivity of the Federal Ministry of Agriculture, Water Management and Forestry, whose cooperation is necessary for the successful completion of selected project assignments, the implementer was not able to meet the contractual deadline on time.
- 1.3. Because of the above-specified objective reason, which was not caused by the Supplies, both contracting parties have agreed on the prolongation of the period of performance of the Contract and hereby enter into this Amendment no. 1.

2. SUBJECT OF THE AMENDMENT

- 2.1. The Supplier and the CzDA have agreed on the following changes to the Contract.
- 2.2. Provisions regarding the period of performance as mentioned in the Article 1. paragraph 3. of the Contract change as follows:

Period of performance:

March 2021 – December 2021

- 2.3. Provisions of Article 3. point c) of the Contract change as follows:
 - c) provide the reports about execution of this Contract in English based on the following scheme:
 - i. until 30th June 2021 for the consultancies and other activities done in first half of 2021
 - ii. until 28th December 2021 for the consultancies and other activities done in the second half of 2021.





The reports shall include narrative description of all activities performed, copies of education materials, attendance lists, subcontracts, photos and other relevant documentation (if not provided earlier).

2.4. Other provisions of the Contract remain unchanged.

3. FINAL PROVISIONS

- 3.1. The Contracting parties acknowledge that this Amendment no. 1 will be published in the contract register according to Act. No. 340/2015 Coll., Contract Register Act, as the CzDA is a liable person within the meaning of this Act and agree with its publication. The CzDA undertakes to ensure the publication within 30 days of the signing of this Amendment no. 1 by both contractual parties.
- 3.2. This Amendment no. 1 becomes effective after the signing of this Amendment by duly authorized representatives of both contractual parties and its publication in the register of contracts.
- 3.3. Done in Prague and Sarajevo in three original counterparts in the English language, from which CzDA will receive two counterparts and the Supplier will receive one counterpart.
