WHEREAS

On May 30, 2018 Elsevier and Lead Institution entered into three Elsevier Subscription Agreements regarding the licensed materials Science Direct ®, Scopus ®, and Knovel ® as defined in Annexes of these three agreements (the “**Agreements**” and each agreement individually as the “**Agreement**”), as last amended by Amendment No.5 on December 15, 2020. The Agreements were published in the Register of Contracts on 25 May 2020.

The Parties intend to update the Agreements related to Scopus ® as specified hereunder due to changes in the subscription of the Institution Research Centre Řež ECR-1055094 from 1 January 2022 and particularly, due to termination of its Scopus subscription on 31 December 2021. Both Parties expressly and irrevocably agree that in the Scopus ® Agreement the Total Fees will be reduced by € 17,678.00 for the subscription year 2022.



NOW, THEREFORE, in accordance with the Agreements, the Parties hereby agree as follows:

1. REVISIONS

By signing of this Amendment, the Parties expressly and irrevocably agree to modify the Agreement as follows:

1.1 In the Agreement related to **Scopus®**, Schedule 1 Subscribed Products/Access/Fees, the table with the prices of Subscribed Products for each Institution shall be modified and replaced (the altered part is highlighted in red) as follows:

1.2 The other provisions of the Agreements shall remain unchanged.

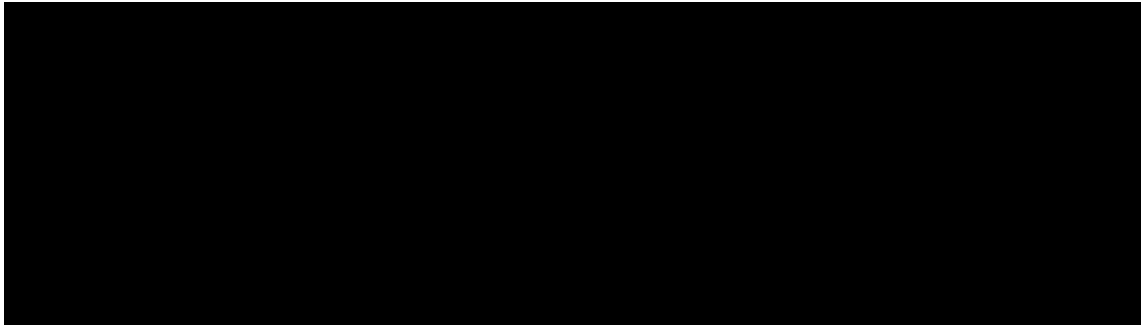
2. MISCELLANEOUS

- 2.1 Regarding the law governing the Amendment and the resolution of any dispute which may arise from it, the Parties have agreed that the corresponding provisions of the Agreements shall apply by analogy.
- 2.2 The Amendment shall be binding upon, and inure to the benefit of, the Parties and their respective legal successors and assigns.
- 2.3 The Amendment shall become valid on the date of signature by both Parties. The Amendment comes into effect on the date of its publication in the Register of Contracts under the conditions stipulated by Act No. 340/2015 Coll., On the Register of Contracts, as amended. The Amendment will be published in the Register of Contracts by the Lead Institution.
- 2.4 No changes, alterations or modifications hereto shall be effective unless made in writing and signed by the Parties.
- 2.5 The Amendment is compiled in three (3) counterparts in the English language, each of which has the power of an original. Elsevier shall receive one counterpart and the Lead Institution shall receive two counterparts.
- 2.6 The Parties agree that electronically signed versions of this originally executed Amendment are acceptable in lieu of printed signed copies and are to be given full force and effect under law and each Party declares that the electronic execution is valid and effective in the jurisdiction the Party executes the Amendment.



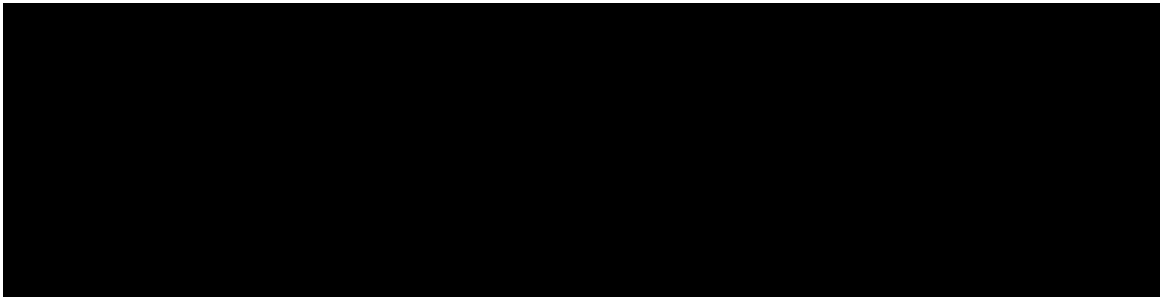
