### I. Modification to the Contract

Following the obligations of the Seller stipulated by the Act No 542/2020 Sb., on products in end-of-life, the Seller is entitled to charge the Buyer with the contributions for operation of the respective take-back collective system in the amount the Seller itself is obligated to pay to the operator of the take-back system. Should the Buyer ask so, the Seller is obliged to document to the Buyer the actual amounts of the contributions.

### II. Final Provisions

1. The terms of the Contract unaltered by this Amendment remain unaffected.
