1. Section 1, paragraph 1.1. is replaced by the following:

"1.1 Requirements for the scope and technical specification

The purpose of this Partial contract is to achieve strong management functions for the most effective utilization of the experiences from the Finland DGR project and with the help of the established JAG to ensure proper planning, monitoring, integration and review function of the activities provided through the Partial Contracts.

Main activities to be performed by the JAG (by Supplier's representatives):

- a) monitoring of the program achievements,
- b) integration of results of the Partial Contracts,
- c) allocation of the support resources to be provided by the Consortium,
- d) planning, monitoring and review of the Partial Contracts fulfillment,
- e) approval of the outputs of the Partial Contracts,

f) expert support and expert evaluation of SURAO materials, presentations (on-demand service).

2. Section 1, paragraph 1.2., is replaced by the following:

"1.2 Required Services deadlines

Milestone 1: Project Management Plan (draft): till 31.12. 2016.

Services within the JAG will be provided until the last partial contract based on FA will be fulfilled but not later than 31.12. 2025"

3. Section 1, paragraph 1.3 is replaced by the following:

"1.3 Estimated labour intensiveness or limitations thereto

Client estimates that the volume of work involved will be 2200 hours."

4. Section 2, paragraph 2.2 is replaced by the following:

"2.2 Fulfilment dates

Draft of the Project Management Plan will be conducted by 31.12.2016 as stated in the Article 1.2.

Services within the JAG will be provided until the last partial contract based on FA will be fulfilled but not later than 31.12. 2025"

The Supplier may suggest changes to the partial deadlines; however, the final deadline should be in line with the requirements of the Client. The Supplier has no suggestions for changes in deadlines presented in this Partial Contract 1."

5. Section 2, paragraph 2.3 is replaced by the following:

"2.3 Price of the Partial Contract"

Based on the Clients estimation on work hours (2200 h), the estimated price of this Partial Contract is 355 280 € plus expenses.

Most of the expenses will be travel costs (air fares, hotel expenses, local travel expenses etc.). All expenses will be documented by archiving the receipts.
