Finalization of chapters 1-9: by 31.12.2024.

4. Section 2, paragraph 2.3 is replaced by the following:

Based on the Clients estimation on work hours (1094 h) divided into classes according to table in chapter 2.4 below, the estimated price of this Partial Contract is 162 000 € plus expenses. Eligible expenses are defined in the Framework Agreement.

All expenses will be documented by archiving the receipts.
