Note: This Partial Contract (PC) has been concluded in compliance with the conditions of a Framework Agreement (FA) signed on 12 October 2016 entitled: "Utilization of foreign experience in the siting process for a deep geological repository for radioactive waste in the Czech Republic".

1 CLIENT'S ASSIGNMENT

1.1 Requirements concerning the scope and technical specifications

SURAO is currently managing a wide range of tasks/projects in various areas in connection with the DGR site selection and assessment process and the development of the overall disposal concept. The purpose of this Partial Contract comprises the provision of the expertise of the Supplier concerning commenting on and reviewing the documents and reports included in the completion of various subtasks specified by the Client. The completion of the subtasks involves reviewing services covering points 2.2 a, i-vii and 2.2.b of the Framework agreement. The relevant specialists will be nominated based on the types of materials to be reviewed. Moreover, the fulfilment of this PC may include the conducting of short expert meetings and discussions and other relevant services based upon the agreement between the Client and the Supplier.

The Client nominates the following person as the Project Manager for the Partial Contract (PC): xxxxx xxxxxxxx, e-mail: xxxxxxxxxxxxxxxxxxxx. The Supplier will communicate directly with this person.

1.2 Required Services deadlines

The work shall commence upon the signing of the Partial Contract, and the estimated duration of the Contract is 48 months.

1.3 Estimated labour intensity and/or its limitation

The Client estimates that the work involved in the PC will amount to up to 3100 hours.

1.4 Specific requirements concerning the organisation of the Services

The work comprises a number of subtasks, each of which includes the submission of one reviewed/commented document or report written in English. The Supplier will be required to act upon demand. The estimate of the amount of work involved and the number of personnel hours involved by category shall be agreed with the Client prior to the commencement of each subtask.

2 CONFIRMATION/MODIFICATION OF THE ASSIGNMENT OF SERVICES BY THE SUPPLIER

2.1 Scope of the Services and technical specifications

The Client shall provide for the reviewing of the respective documents in English.

The Supplier shall perform the assignment of the Services as set out by the Client in Article 1.1.

The approach via which the Supplier conducts the assignment shall be as follows:

1. To comment on and review the respective documents and reports written in English as specified by the Client for each of the subtasks
2. The provision of a review memorandum for each subtask that includes all the review comments and opinions
3. Discussions with the Client on the various comments and recommendations (via optional meetings)
4. The conducting of additional expert meetings and discussions and other relevant services as required by the Client

2.2 Fulfilment dates

The Supplier suggests the time schedule for the provision of the Services to the Client as stated in Article 1.2.

2.3 Price of the Partial Contract

The price of the PC (exclusive of travel costs) has been estimated based on the Cat. 2 and Cat. 3 fees set out in the FA at (assuming 3100 hours) EUR 409 065. Estimates of the work and the personnel hours by category shall be agreed with the Client prior to the commencement of each subtask. The Supplier shall be required to justify all the expenses incurred. The holding of consultation meetings at the Client's premises will necessarily incur travelling expenses. Such travelling expenses shall be invoiced as incidental costs separately according to point 4.2.2 of the Framework agreement.

2.4 Organisation of the Services

Aimed at determining the most suitable persons for each of the subtasks, the Supplier shall nominate the experts to be involved separately for each subtask. When determining the labour intensity, the Supplier shall take into account the limit set by the Client in Article 1.3 of the Partial Contract (max. 3100 hours).

The Supplier shall provide details of the organisation involved and the accountability of the persons involved in the Partial Contract in Table 2. The estimated hours per category are listed in Table 3. Changes to the personnel hours per category are permitted in agreement with the Client.
