This agreement amends the Partnership Agreement - Project Number – 591988-EPP-1-2017-1-CZ-EPPKA2-SSA-B, Development and Research on Innovative Vocational Education Skills bearing the effective date of July 7th, 2018 and Amendment No. 1 bearing the effective date of February 8th, 2021 between VŠB-TECHNICAL UNIVERSITY OF OSTRAVA (the “Coordinator”), and ACEA – European Automobile Manufacturers Association (the “Beneficiary”). This Amendment shall take effect on the date of its publication in the register of contracts pursuant to Act No. 340/2015 Coll., on the register of contracts. The publication of the Amendment in the register of contracts will be ensured by the Coordinator.

As provided for under the terms of this Amendment, the Coordinator and the Beneficiary agree to amend the following provisions of the Partnership Agreement:

Article 1.4 Maximum amount and form of the Grant, 1.4.2 The Erasmus+ grant contribution is awarded to the partnership under the form of: paragraph (b) A unit contribution of budget calculated via unit costs (“unit contribution”) covering the following categories of eligible costs: activities directly linked to the implementation of the project (per day/per category of staff/per group of country) as indicated in Annex I.

The total grant for ACEA is being increased by 20.519 EUR from **195.380 EUR** indicated in previous Amendment No. 1 to **215.899 EUR** as indicated in Annex I of the Amendment No. 2.

All other terms and conditions as set forth in the original Partnership Agreement shall remain in effect for the duration of this Partnership Agreement.

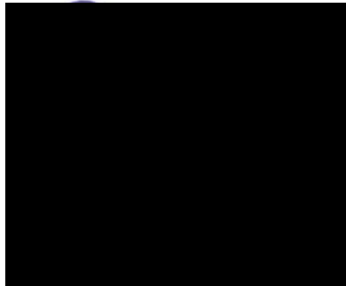

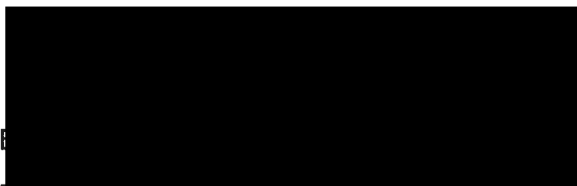
