

## AMENDMENT No. 2

### To the Partnership Agreement

Between

**Masaryk University** (hereafter the Coordinator)

Seat: Žerotínovo nám. 9, 601 77 Brno, Czech Republic

Represented by: prof. MUDr. Martin Bareš, Ph.D., Rector of the MU

and

**Cardiff University** (hereafter the Partner)

Seat: Newport Road 30-36, Cardiff, CF24 ODE

Represented by: Dr. David Bembo, Director Research & Innovation Services

On the December 3<sup>rd</sup> 2019, the Contracting Parties have concluded the Partnership Agreement concerning cooperation on S.P.I.D.E.R. project (hereinafter referred to as the "Agreement").

The Contracting Parties decided to conclude this Amendment in connection with the amendment No. 2 The Grant Agreement number 2019-1-Cz01-Ka202-061350, which was concluded by the coordinator with the grant provider on the August 9<sup>th</sup> 2021 (hereinafter referred to as the "Amendment to the Grant Agreement").

#### I. Adjustments to the Agreement

1. The Contracting Parties hereby replace the second paragraph of Article 2 - Duration of the Agreement with the following wording:

*"The effect and the period of eligibility of costs shall be in force from 01. 09. 2019 and shall end on 31. 8. 2022. The effect of the Contract shall end by the reimbursement of the Balance payment to the Partner."*

#### II. Final provisions

1. All other terms and conditions of the Agreement shall remain in effect and unchanged.
2. This Amendment shall enter into force upon signature by both Contracting Parties on the date of the last signature. The effective date is the date when a copy of this Amendment has been published in a Registry of contracts according to the Act no. 340/2015 Coll. of the Czech Republic, on special conditions for the effectiveness of some contracts, the disclosure of these contracts and the Registry of contracts (Act on the Registry of contracts). Parties declare that they agree that the Agreement and the Amendment No. 2 will be published in the Register of contracts under the conditions of the Act on the Register of contracts.
3. Parties declare that the confidential parts of the Agreement and the Amendment No.2 will not be published in the Register of contracts. If Parties will not disclose the Agreement or its parts in the Register of contracts under the Act on the

Register of contracts they are pursuing the mutual protection of legitimate interests.

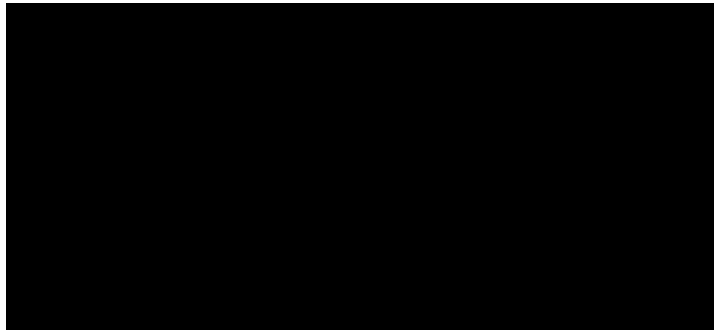
