1. Remuneration

The Contracting Parties have hereby negotiated Remuneration for the Provider in the following amounts:

2. Payment Conditions

The Contractor commits to pay the separate parts of the Remuneration to the Provider in the following manner:

- The entitlement for paying the part of the Remuneration for the provision of ISDSBIM Licences according to item A) of the table in Appendix No. 3 of the Contract equals 1/41 of the overall Remuneration sum set out in item A) monthly. The pertinent part of the Remuneration given by this paragraph is payable always in advance for the period of one (1) year, for which the ISDSBIM Licences are provided to the Contractor, or eventually their proportionate part if the ISDSBIM Licences are provided to the Contractor for a whole year. The pertinent part of the Remuneration is payable on the first day that the Provider provides the Contractor with the ISDSBIM Licences, and the next pertinent part of the Remuneration for the ensuing periods are always payable on the first day following the end of the previous period, when the Contractor uses the ISDSBIM Licences.
- The entitlement for payment of part of the Remuneration for providing the Licences for the Public DSBIM according to item B) of the table in Appendix No. 3 of the Contract equals 1/41 of the overall Remuneration according to item B) monthly. The pertinent part of the Remuneration according to this paragraph is payable always in advance for the period of one (1) year for which the Licence to the Public DSBIM is provided to the Contractor, or eventually its proportional part if the Licence to the Public DSBIM is not provided to the Contractor for the entire year. The pertinent part of the Remuneration is payable on the first day that the Provider provides the Contractor with the Licence to the Public DSBIM, and the next pertinent part of the Remuneration for the next period is payable always on

the first day following the end of the previous period for which the Licence to the Public DSMBIM is used.

- The entitlement for the payment of part of the Remuneration for providing the API ISDSBIM Licence according to item C) of the table in Appendix No. 3 of the Contract equals 1/41 of the overall part of the Remuneration according to item C) monthly. The pertinent part of the Remuneration according to this paragraph is payable always in advance for the period of one (1) year for which the API ISDSBIM Licence is provided to the Contractor, or eventually its proportional part if the API ISDSBIM Licence is not provided to the Contractor for the entire year. The pertinent part of the Remuneration is payable on the first day that the Provider provides the Contractor with the API ISDSBIM Licence, and the next pertinent part of the Remuneration for the next period is payable always on the first day following the end of the previous period for which the API ISDSBIM Licence is provided.
- The entitlement for payment of part of the Remuneration according to item D) of the table in Appendix No. 3 of the Contract - the access to the System and customization of the System - is established on the day following the commencement of System operations in accordance with 3.19.3 of the Contract.
- The entitlement of the Provider to the payment of part of the Remuneration according to item E) of the table in Appendix No. 3 of the Contract is established on the first day after the data transfer from the CBT to the System in accordance with paragraph 3.22 of the Contract is completed.
- The entitlement of the Provider to the payment of part of the Remuneration according to item F) of the table in Appendix No. 3 of the Contract is established on the first day of the calendar month following the month when the Provider stopped providing the pertinent Consultation Services. The amount of the pertinent part of the Remuneration will be calculated in the amount of 1/240 of the Remuneration for the provision of Consultation Services multiplied by the actual extent (hours) of Consultation Services provided;
- The entitlement of the Provider to the payment of Remuneration according to item G) of the table in Appendix No. 3 of the Contract - Training - is established on the day following the end of the pertinent training session; the amount of the pertinent part of the Remuneration shall be calculated in the amount of 1/10 of the Remuneration for the provision of training multiplied by the actual extent (training days) of the training.
- The entitlement of the payment of the Remuneration according to item H) of the table in Appendix No. 3 of the Contract for the provision of the Remuneration for 12 months of the ISDSBIM Licences according to paragraph 3.5 of the Contract is always payable in advance for the period of one (1) year for which the ISDSBIM Licences are to be provided to the Contractor, or eventually its proportional part, if the ISDSBIM Licences are not provided to the Contractor for the entire year. The pertinent part of the Remuneration is payable on the first day that the Provider provides the Contractor with the ISDSBIM Licences and the next pertinent part of

the Remuneration for the next period is payable always on the first day following the end of the previous period when the ISDSBIM Licences are used.
