1. Term and Access Rights

- 1.1 The Term shall begin on 15th December 2021 (the “Commencement Date”) and shall end on 31st December 2022.
- 1.2 After expiration of the Term, Licensee shall have Continuing Access to the eBook Collections indicated in Section 3.1, subject to all terms and conditions of this License Agreement.

2. Estimated Titles

The License Fee is based on the inclusion of the Estimated Number of Titles (as referenced in the table in Section 3.1) in the licensed eBook Collections. If the total number of eBooks, excluding Open Access books, in the eBook Collections licensed under these Product Terms is less than 97% of the estimated number of titles for all licensed eBook Collections, Licensor shall, at Licensee’s request, offer Licensee a credit toward either (a) current access to an additional online product, or (b) future acquisition of an eBook Collection or any other online product, in an amount equal to 1% of the License Fee for each full percentage point that the actual number of titles is below 97% of the estimated number of titles for all licensed eBook Collections.
