The contracting parties hereby conclude the present Annex No. 1 to the above-designated
Contract:

1. The Article II, par. 2.8. is changed as follows: The tuition fee for the discipline of
“**General Medicine**” is **CZK 280,000.00** per year. The tuition fees do not comprise
costs of accommodation, food, insurance of students, and the like. Such expenses
have to be carried by the students themselves.”
2. The Article II, par. 2.9. is changed as follows: The tuition fee for the discipline of
“**Dentistry**” is **CZK 330,000.00** per year. The tuition fees do not comprise costs of
accommodation, food, insurance of students, and the like. Such expenses have to be
carried by the students themselves.”

3. Article VI. Disclosure of the Contract shall be added after the Article V. and shall read as follows:

1. *Parties acknowledge that the Faculty is an obligated subject under the Act no. 340/2015 Coll. of the Czech Republic, on special conditions for the effectiveness of some contracts, the disclosure of these contracts and the Registry of contracts (Act on the Registry of contracts). Parties declare that they agree that the Contract and all its amendments will be published by the Faculty in the Register of contracts under the conditions of the Act on the Register of contracts.*
2. *Parties declare that the confidential parts of the Contract and its amendments will not be published in the Register of contracts. If Parties will not disclose the Contract or its parts in the Register of contracts under the Act on the Register of contracts they are pursuing the mutual protection of legitimate interests.*

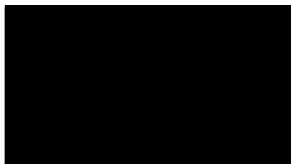
4. The other parts of the Contract remain unchanged

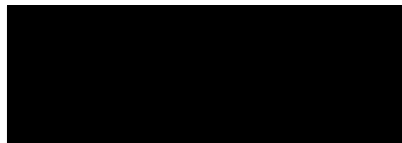
