### Article 1 Parties

### Article 2 Legal Basis

1. The parties to this Agreement have concluded the Student Exchange Agreement on 3. 3. 2020.

2. The mentioned Student Exchange Agreement provided that it would retain its validity and all its effects for a period of two years.
3. The mentioned Student Exchange Agreement provided that it would be renewed (prolonged) only upon mutual accord of the parties and only in writing.

### **Article 3 Prolongation**

1. The parties to this Agreement have reached their mutual accord and intent on prolongation (renewal) of the Student Exchange Agreement dated 3. 3. 2020.
2. The parties to this Agreement therefore provide that the Student Exchange Agreement dated 3. 3. 2020 shall be prolonged in the manner that it shall retain its full validity and full effectiveness continuously for another period of **two years** after its original expiration.

### **Article 4 Limitation of Scope**

1. The parties to this Agreement provide that this Agreement does not amend or affect any other provision or clause of the Student Exchange Agreement dated 3. 3. 2020 except for the duration of its validity and effects.

### **Article 5 Validity, Effects, and Amendments**

1. The parties to this Agreement provide that this Agreement shall become valid and completely effective immediately upon its signing by both parties.
2. The parties to this Agreement provide that this Agreement shall be amended only upon their previous mutual accord and only in writing.

### **Article 6 Publicity**

1. The UO is an obliged entity pursuant to Act No. 340/2015 Coll., Act on the Register of Contracts (hereinafter the "Act on the Register of Contracts"). KMU acknowledges and expressly agrees that this Agreement in full is subject to publication in the Register of

Contracts (information system of public administration, administered by the Ministry of the Interior). The UO undertakes to publish this Agreement in compliance with the provisions of the respective Act on the Register of Contracts.

**Article 7**  
**Validity, Effects, and Amendments**

1. This Agreement is made in exactly two duplicate originals.
2. Each party to this Agreement shall hold exactly one of the mentioned originals.
