Cooperation Agreement

between

Palacký University Olomouc and Aarhus University (hereinafter collectively “Parties”) agree to establish cooperation aimed at implementation of mobility of the Palacký University’s researcher specified hereunder (hereinafter the “participant”).

Article 1

Within the field of research specified below, Palacký University Olomouc and Aarhus University agree on the following cooperation under terms set out herunder:

Mobility of the participant from the Palacký University at the premises of Aarhus University within the project Support of mobility at Palacký University Olomouc II, CZ.02.2.69/0.0/0.0/18_053/0016919; (hereinafter “the project”) implemented by Palacký University Olomouc within the framework of EU operational programme Research, Development and Education (hereinafter “the mobility”).

Article 2

Mobility description – goals, focus, schedule.

1. The mobility will be carried out at the Department of Physics and Astronomy, Aarhus University under the supervision of the Mentor, [REDACTED]
2. Participant of the mobility: [REDACTED] employed at Palacký University Olomouc at Department of Optics as researcher, email address: [REDACTED], telephone: [REDACTED]



3. Both Parties agree on the time schedule of the mobility from 1.2.2022 to 30.4.2022, (hereinafter the “mobility period”).
4. Field of research and scientific content of the mobility: Quantum Optics.
5. For the purpose of specification of further technical details of the scientific content of the mobility and organizational arrangements pertaining thereto, Palacký University Olomouc will be represented by [REDACTED], email address: [REDACTED] (hereinafter “contact person of PU”) and Aarhus University will be represented for the purpose of organizational arrangements pertaining to the mobility by [REDACTED] email address: [REDACTED] (hereinafter “contact person of the host institution”).
6. Both Parties agree that the results of the common research conducted within the mobility hereunder by employees of both Parties will be published in the form of open access publications. The charges will be covered by Palacký University Olomouc unless specified otherwise.
7. The Parties further agree that the wage of the participant payable in connection with realization of the mobility and the travel expenses of the participant pertaining thereto will be covered by Palacký University Olomouc. These expenditures will be reimbursed within the framework of the project costs by Palacký University Olomouc on basis of the labor-law relationship with the participant. Aarhus University does not have any financial claims towards Palacký University Olomouc concerning mobility hereunder and Palacký University Olomouc does not have any financial claims towards the Aarhus University concerning the mobility.
8. The Parties undertake an obligation to ensure that during the mobility period the participant will perform exclusively non-economic activities.
9. Each contractual party hereto is obliged to communicate to one another any problems or necessary changes regarding the mobility.
10. In case of force majeure disallowing the participant to carry out the mobility in person at the premises Aarhus University above, especially in the event that restrictive measures are introduced by the pertinent state authority, in connection with the COVID-19 pandemic, prohibiting the participant to do so, including but not limited to travel bans, further lock down measures etc, the Aarhus University shall enable the participant to carry out the mobility in the mode of work from home provided that the contact persons under paragraph 5 of this article approve of it and provided that the work from home will only be carried out as long as the force majeure lasts (in particular as long as the restrictive measures are in effect), whereas the length of work in this mode shall not exceed 1/3 of the total time of duration of the mobility period. The contact persons under paragraph 5 of this article may also stipulate the interruption of the mobility and conditions thereof.

Article 3

1. Parties hereto acknowledge the fact that this agreement is subject to obligatory publication under the Czech Act No. 340/2015 Coll. On Special Conditions of Effect of certain Contracts, Publication of these Contracts and on the Register of Contracts (Act on the Register of Contracts) due to the fact that the value of this agreement exceeds CZK 50 000 without VAT.

2. Palacký University Olomouc, which shall ensure publication hereof in the Register of Contracts, shall inform the other party of its publication immediately thereafter using the email address of the contact person of the host institution.
3. This agreement is concluded as of the date of appending of signatures of authorized representatives of the parties hereto and comes into effect as of the date of its publication in the Register of Contracts in accordance with the aforementioned act.
4. The parties hereto undertake to refrain from launching to provide any performance hereunder prior to the date of the effect hereof.
5. Amendments hereto may be made by written agreements of both Parties with signatures of their duly authorized persons on one deed. This stipulation may not be changed by subsequent agreement in any form.

Article 4

This Agreement may be terminated in writing by agreement of the Parties with signatures of their duly authorized persons on one deed.

Article 5

The duration of this agreement is determined by the mobility period.
This Agreement is executed in four copies, two copies for each Party.

Article 6

The Parties subscribe to the policy of equal employment opportunity and non-discrimination of person on grounds of race, colour, religion, sex, sexual orientation, age, nationality, marital or veteran status, and physical or mental disability. Palacký University Olomouc, and Aarhus University shall abide by these principles in the implementation of this agreement
