



AMENDMENT NO 2

(the Buyer and the Seller are hereinafter jointly referred to as the "Parties")

1. MODIFICATION OF THE CONTRACT

- **1.1** Art. 7 par. 7.1. of the Contract is hereby cancelled and replaced with the following wording:
 - 7.1 The Seller hereby provides a warranty of quality of the Object of Purchase for the period of 24 months, unless this Contract or its amendments stipulates otherwise.
- **1.2** Art. 7 par. 7.14 is hereby added hereto with the following wording:
 - 7.14 The Seller hereby provides a warranty of quality of the New stacks (as defined in Annex No. 1 hereto) for the period of **24 months from their installation or 42 months** from the date of the signature of the Site Acceptance Test Protocol which forms an Annex No. 1 hereof, whatever comes first.

2. FINAL PROVISIONS

- 2.1 All provisions of the Contract unaltered by this Amendment remain valid.
- 2.2 The Parties, manifesting their consent with its entire contents, affirm the Amendment with their signature.
- 2.3 The Parties agree to publish the full text of this Amendment, in the Register of Contracts pursuant to Act No. 340/2015 Coll., on Special Conditions for the Effectiveness of Certain Contracts, the Disclosure of These Contracts and the Register of Contracts, as amended (Act on the Register of Contracts).
- 2.4 This Amendment shall become valid on the date of the signature of both Parties. This Amendment shall become effective on the date of its publication at Register of Contracts.


