CONDITIONS

ARTICLE 1 - PURPOSE OF THE CONTRACT

- 1.1. The sending institution will provide Community financial support to the participant for undertaking a Training Placement under the KA122 mobility in vocational education and training of the Erasmus+ Programme and will pay for the services indicated in this contract to the host institution.

- 1.2 The host institution undertakes to carry the services referred to in this Agreement in the Article 4 Payment Arrangements in accordance with Erasmus+ learning agreement complement.

ARTICLE 2 - DURATION

2.1 The contract shall enter into force on the date when the last of the two parties signs.

2.2 The Training Placement shall start on 29th May 2022. The total number of days spent in Mersin will be 21.

ARTICLE 3 - FINANCING THE TRAINING PLACEMENT

3.1 For the placement governed by this Agreement, the sending institution undertakes to finance mobility expenditure in accordance with the financing rules established by the Erasmus+ National Agency.

ARTICLE 4 - PAYMENT ARRANGEMENTS AND SERVICES

- 4.1 The sending institution undertakes to pay to the host institution the total amount of € 11 000,- (eleven thousand euros) to arrange the following paid services regarding the training placement for 8 interns + 1 teacher:
 - 21- day accommodation at the hotel or appartment including breakfast for the interns
 - . 21- day accommodation at the hotel or appartment including breakfast in a single room for the teacher
 - local travel pass for 19 days for the interns
 - · local travel pass for 19 days for the teacher
 - PCR tests for 8 interns (each intern will be tested twice a week = 6 PCR tests per one Intern)
 - Transfer from Adana airport (Adana Mersin on the day of arrival, Mersin Adana on the day of departure)
- 4.2 The host institution undertakes to provide the following free of charge services for the sending institution within the framework of the internship:
 - arrangement of the work programme according to the Learning agreement
 - working hours for the interns 6 hours per day / 5 days a week
 - · monitoring of the work programme
 - issuing of the Europass Mobility certificates and completion of Learning agreement complement
- 4.3 The sending institution undertakes to pay as follows:
 - 1. payment € 6 000,- entil 30th April 2022
 - 2. payment € 5 000,- until 10th May 2022
