# COOPERATION AGREEMENT FOR PURPOSES OF THE *Transparency of Colours* EXHIBITION

### I. Parties

# II. Subject of the Contract

- 1. Subject matter of the contract is the cooperation of UMPRUM and GlazenHuis on realization of the project of the preparation and organization of the exhibition realized by The Studio of Glass UMPRUM (hereinafter as "Studio") under the governance of Mr. Rony Plesl with the working title" Transparency of Colours" (hereinafter as "Exhibition") within the works of art designed by Studio will be presented (hereinafter as "Artworks"), listed in Annex 1 of the Agreement (hereinafter as "Annex 1") in GlazenHuis premises (hereinafter as "Premises").
  - The Exhibition will be open to the public: April 2 October 9 2022.
- 2. **UMPRUM** is bound to provide in the time and extent agreed by this Contract with the following services:
  - A) The preparation (selection of the Artworks and the participating artists) of the Exhibition. (incl. Situation Plan of Artworks in Premises)
  - B) Organizing door to door transportation + shipping costs of the Artworks to Premises.
  - C) Insurance of Artworks for the period of its transport and installation.
  - D) Installation of Artworks in Premise in the period March 28 April 1, 2022.
  - E) Graphic design of all propagation and presentation materials:
  - A5 flyer for visitors with brief exhibition information. (Delivery deadline English text for translation to Dutch: March 11, 2022)

- Labels for the Artworks
- Vinyl wall text (delivery deadline digital wall print file: March 22)
- F) Writing, designing, printing of the Exhibition catalog.
- G) A prize list of the Artworks, which are for sale (Comission GlazenHuis: 30% ex.VAT)
- 3. **GlazenHuis** is bound to provide in the time and extent agreed by this Contract with the following services:
  - A) Plan documentation of Premises
  - B) Own Premises (incl. energy and water supply)
  - C) Personal technical support during installation of Artworks in Premise by the museum staff.
  - D) Translation of the English exhibition text to Dutch.
  - E) Print of Exhibition materials and graphic materials for the exhibition including:
  - Exhibition poster
  - Vinyl wall print + installing of the vinyl wall print, March 29, 2022.
  - A5 flyer in Dutch and English
  - Labels for the Artworks
  - F) Insurance of the Artworks
  - G) Photography of the exhibition, April 1, 2022, 10 AM.
  - H) Organizing lodging for the UMPRUM team + the residency
  - I) Facilities of the hot and cold glass studio + 1 assistant for the residency 14-20 March 2022 (purpose of the residency: Making an installation for the tower of GlazenHuis)
  - J) Guided tour for the museum guides
  - K) Catering for the official opening, April 1, 2022.

# III. Place and Terms of Exhibition

- 1. The Exhibition will be situated in premises of GlazenHuis at the following address: Dorp 14, 3920 Lommel, BE.
- 2. The Exhibition will be held from April 2 to October 9, 2022 with its official opening ceremony on April 1, 2022, 7 PM.

#### IV. Share of the Costs

1. The Contractual parties have agreed that the costs for (i) the preparation of

Exhibition provided by UMPRUM, (ii) door to door transportation of Artworks to GlazenHuis premises (iii) insurance of Artworks for the period of its transport and during the Exhibition will be paid by UMPRUM. The costs will be paid by UMPRUM directly to the third parties providing these services; the selection of their suppliers is provided exclusively by UMPRUM.

2. The Contractual parties have agreed that the GlazenHuis will pay sum of 12,000.00 EUR (split in two invoices) as its share on realization of the project of the preparation and organization of Exhibition.

### V. Other Provisions

- 1. The UMPRUM declares it is authorized to display the Artworks at Exhibition.
- 2. The Artworks will be used exclusively for the purposes of Exhibition specified in this Agreement.
- 3. UMPRUM should be informed of any loss or damage to, or material change in the condition of Artwork. This shall be noted on the written description of the loss, damage or change in condition, together with photographic documentation and a statement of how it occurred (if known), will be sent by email and mail to the Partner within 48 hours after such loss, damage or change in condition.
- 4. Photography of the Artworks by the general public for non-commercial purposes is permitted provided that photographs are taken without the use of either a flash or a tripod. Any other photography should be taken only after prior written permission of UMPRUM.
- 5. The Exhibition is supported by sponsors and promoters. GlazenHuis should deliver all logos of the sponsors/promoters as digital files in print quality.

### VI. Contract Termination

- 1. This contract may be terminated by agreement of both parties.
- 2. The lender has the right to demand return of borrowed items earlier, for the reasons that he could not predict when the contract was concluded OR any Artwork is not used in accordance to the terms specified above.

### VII. Final Provisions

- 1. The contracting parties declare that they have read the contract before signing, agreed with its content and as a proof they affix their signatures.
- 2. Changes and amendments to this agreement are possible only in writing and by mutual agreement of both parties.
- 3. This agreement is made in two original copies, each party shall receive one.
- 4. The rights and obligations herein unsaid shall be governed by the provisions of Act No. 89/2012 Coll., of The Civil Code.
