CONDITIONS

ARTICLE 1 – PURPOSE OF THE CONTRACT

- 1.1 The sending institution will provide Community financial support to the participant for undertaking a Training Placement under the KA122 mobility in vocational education and training of the Erasmus+ Programme and will pay for the services indicated in this contract to the host institution. - 1.2 The host institution undertakes to carry the services referred to in this Agreement in the Article 4 Payment Arrangements in accordance with Erasmus+ VET Mobility Quality Commitment.

ARTICLE 2 - DURATION

- 2.1 The contract shall enter into force on the date when the last of the two parties signs.
- 2.2 The Training Placement shall start on 29th May 2022. The total number of days spent in Riga will be 21.

ARTICLE 4 -- PAYMENT ARRANGEMENTS AND SERVICES

- 4.1 The sending institution undertakes to pay to the hosting institution the total amount of € 9160 to arrange the following services regarding the training placement for 8 interns + 1 teacher.
 - 21-day all-inclusive accommodation without dinners for the interns
 - 5-day accommodation in a single room for the teacher
 - · arrangement of the Work Programme according to the Learning agreement

 - working hours for the interns 6 hours per day / 5 days a week
 - monitoring of the Work Programme
 - · Guided activities and tours round the city of Riga including transport
 - · Guided activities and tours outside the city of Riga including transport
 - sending information about Work Programme, Work Placements and accommodation for each intern three weeks prior scheduled arrival at the latest
