who hereby in accordance with provisions of §2430 and subsequently Act no. 89/2012 Coll. of the Civil Code as amended conclude this Addendum No. 1. amending the following provisions of the Contract

II.

Subject of This Contract

1. The subject of this contract is Mandatory's obligation to provide for the Mandator work consisting of an archaeological investigation related to discoveries at Tell Timai, in particular a basic survey and acquisition of archaeometric data related to possible residues in the artifacts found, including analyses and hypotheses pertaining to their original contents and their botanical origins. The Mandatory will also be required to come to Prague to discuss the completed work with the Principal investigator of the project Alchemies of Scent. Reconstructing the Practices of Ancient Greco-Egyptian Perfumery: An Experimental Approach to the History of Science (reg.no.: 21-30494M) in detail; furthermore, the Mandatory will write up the results of the study as part of the research outputs of the Alchemies of Scent project.

III.

Schedule of Performance of the Mandate

1. The Mandatory will perform the mandate from 1.11.2021 until 31.8.2022.
2. Mandatory will perform the mandate continually during the entire duration of a period specified in par. 1 of this article.

**V.
Remuneration**

1. Remuneration for the performance of the mandate is determined by Contract and Addendum and amounts to the total of 100.000 CZK, i. e. the remuneration is increased by 40.000 CZK.
2. The Mandator will cover costs of accommodation for the Mandatory, that incurred in direct temporal and material connection with activity specified in Article II of the Contract and Addendum to the following extent:
 - a) costs of accommodation for 9 nights (at most 1.000 CZK per night);
 - b) The Mandator will cover the costs in the form of cashless transfer based on invoice from the accommodation provider

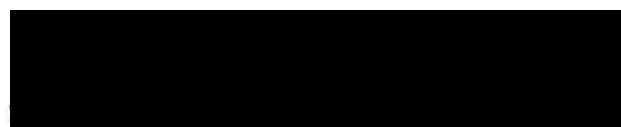
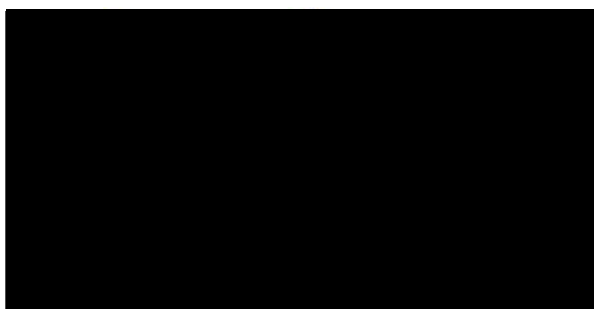
