VII. OTHERS

1. If the performance(s) as described in part I. do not take place due to the performer (theatre) fault, there will be no claim for the fee and related cost. In this case the

performer (theatre) must pay to the festival the expenses provably spent for the realization of the performance(s).

2. In the case of cancellation or failure to perform due to force majeure (illness, accident, impassability of roads, etc.), both parties are obliged to notify each other immediately by phone and withdraw from the contract without compensation, or agree to change the production or date and always confirm this agreement in writing.

According to this agreement, force majeure is considered to be all events that arise in connection with the measures related to the COVID 19 pandemic.

- 3. If the performance/s as described in part I. does not take place due to festival fault, related cost will be paid.
- 4. If partial acceptable performances are delivered the fee will be reduced accordingly.
- 5. Both sides agree that this performance(s) is(are) presented on the base of cooperation between festival and theatre, so any will present a claim on any others payments. The validity of this contract will be established only after signature of both parts.
