CONTEXT AND RATIONALE

Context:

Competitiveness of Serbian enterprises is closely connected with their ability to produce quality and safe products, conformed to the requirements of relevant technical regulations and standards. An efficient and internationally recognized national quality infrastructure (NQI) system that enables Serbian enterprises to implement technical regulations and standards for products is one of the prerequisites for the competitiveness of the Serbian economy.



An important instrument for enhancing competitiveness of Serbian industry recognized in the Strategy for industrial Development for the period 2011-2020 is harmonization of technical regulations and standards with international, i.e. EU rules, and strengthening of relevant institutions is an important prerequisite in creating business environment and enhancing trade of products within EU market.

With effect from 2013-07-01 and in accordance with the new EU Construction Products Regulation 305-2011 (CPR), all construction products complying with harmonized European standards and intended for sale on the internal European market have to be CE marked and accompanied by a Declaration of Performance (DoP).

Transposition of CPR Regulation is currently ongoing in Serbia.

CPR aims to overcome the technical barriers to trade which arise where different countries in Europe have different standards, testing and labelling approaches for the same construction products. It is therefore essential that all parties within the construction product supply chain learn, understand and implement adequately the legal requirements. Serbian companies face a strong challenge to increase their competitiveness and export potential. Support is needed in order to help Serbia to improve its business environment and increase the trade with EU countries. Czech experience during pre-accession and after-accession period will be of great importance for improving activities of Serbian quality infrastructure system, and particularly Ministries responsible for Construction products.

In addition, the successful transposition and implementation of the EU technical legislation regulations, namely in the field of construction products legislation, is one of the preconditions for successful negotiations between Serbia and the EU within the Negotiation Chapter 1 (Movement of Goods)

Expected outputs and outcomes:
