AFTER TICKETING/BEFORE CHECK-IN OF THE FIRST FLIGHT

Name corrections are permitted for all classes, for details, check with the Group Desk.

Name changes (name and surname):

- Business and Premium Economy cabin: it is allowed free of charge.

- Regular groups tickets: The original group ticket will be reissued. Fees may apply.

It is not allowed to make any type of modification or change in the name after the departure.

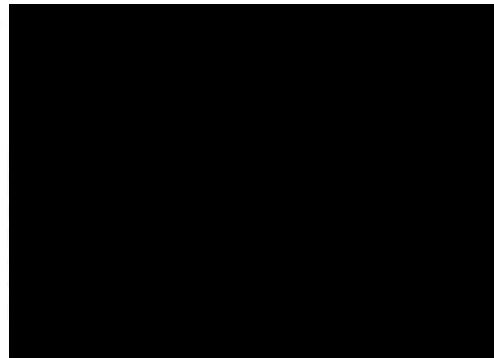
