WHEREAS:

- A) On 28 March 2019, the Parties entered into the DAOA, in order to regulate their cooperation in respect of the operation and further development of the Cooperation, in addition to other agreements such as the NEMO Only Agreements, and the TCDA;
- B) By the First DAOA Amendment dated 14 January 2022 the DAOA was amended;
- C) The Parties now wish to amend the DAOA to implement the so-called qualified majority voting mechanism (hereafter the "**QMV**"), as further detailed in Article 12 of the DAOA;
- D) For information purposes only, TGE & PSE hereby declare that they have the status of a large enterprise, as defined in Article 4 (6) of the Polish Act on counteracting excessive delays in commercial transactions (Dz.U. [Journal of Laws] from 2020, item 935, 1086, as amended). This status is also defined in Commission Regulation (EU) No 651/2014 of 17 June 2014 declaring certain categories of aid compatible with the internal market in application of Articles 107 and 108 of the Treaty on the Functioning of the European Union (OJ EU L 187, 26 June 2014, as amended).

NOW THEREFORE THE PARTIES AGREE AS FOLLOWS:

1. General

- 1.1** Capitalized terms used in this Second DAOA Amendment shall have the meaning attributed to them in Annex 1 (Definition List) to the DAOA unless otherwise specified in this Second DAOA Amendment.
- 1.2** This Second DAOA Amendment contains certain amendments to the DAOA and should be read in conjunction with it. Except as expressly set out in this Second DAOA Amendment, the DAOA remains unaffected and in full force and effect.

2. Amendments to the DAOA

- 2.1** The Parties agree to replace the entirety of the text of the main body of the DAOA by the text set forth in Annex 1 (“Consolidated version of the main body of the Single Day-Ahead Coupling Operations Agreement with the First DAOA Amendment and Second DAOA Amendment provisions”), which shall be binding and constitute the definitive document between the Parties regarding the content of the main body of the DAOA. For informational purposes only, Annex 2 (“Consolidated version of the main body of the Single Day-Ahead Coupling Operations Agreement with the First DAOA Amendment and Second DAOA Amendment provisions - Mark up”) shows the changes compared to the version of the DAOA as consolidated with the changes from the First DAOA Amendment.
- 2.2** As agreed in the First IDOA Amendment (i) any reference to “*Single Day-Ahead Coupling*” in the Agreement shall be understood as being replaced by a reference to the acronym “*SDAC*” and (ii) any reference to the acronym “*JSC*” in the Agreement shall be understood as being replaced by a reference to the acronym “*MCSC*”.
- 2.3** The Parties agree:
- 1) to attach the binding Consolidated version of the main body of the Single Day-Ahead Coupling Operations Agreement with the First DAOA Amendment and Second DAOA Amendment provisions, as foreseen in article 2.1, as Annex 1 to this Second DAOA Amendment;
 - 2) to attach for informational purposes only the Consolidated version of the main body of the Single Day-Ahead Coupling Operations Agreement with the First DAOA Amendment and Second DAOA Amendment provisions - Mark up, as foreseen in article 2.1, as Annex 2 to this Second DAOA Amendment;
 - 3) to replace the current Annex 1 (Definition List) to the DAOA by the

adapted Annex 1 (Definition List) attached as Annex 3 to this Second DAOA Amendment;

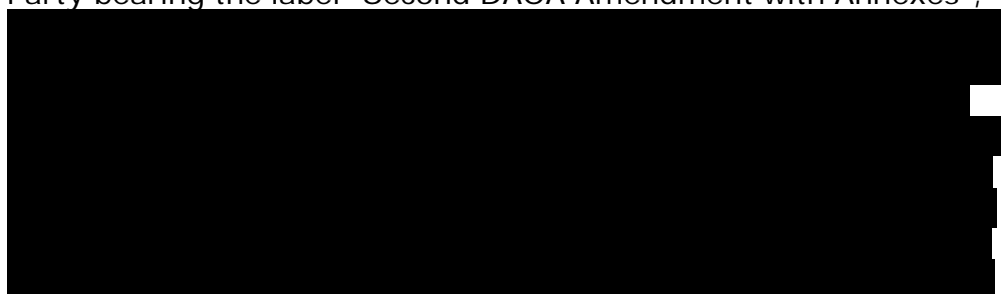
- 4) to replace the current Annex 4 (Rules of Internal Order) to the DAOA by the adapted Annex 4 (Rules of Internal Order) attached as Annex 4 to this Second DAOA Amendment;
- 5) to attach the Statistical data to be used for the calculation of the voting share attached as Annex 5 to this Second DAOA Amendment as Annex 13 to the DAOA (Statistical data to be used for the calculation of the voting share);

3. Entry into force, applicable law and dispute resolution

3.1 This Second DAOA Amendment shall enter into force as of 1 September 2022, provided that i) all Parties have signed it by sending a scan of the signed signatory page of the Second DAOA Amendment to a third coordinating party assigned by the Parties and ii) the amendment to the IDOA to implement the QMV has been signed by all its parties. The third coordinating party will collect all copies of the received signed signatory pages and provide a copy of the main text of the Second DAOA Amendment with the copies of the signed signatory pages to the Parties.

3.2 For evidence reasons:

- i) each Party shall also provide the third coordinating party with forty-nine (49) original signed signatory pages (one per Party) of the Second DAOA Amendment. The third coordinating Party will collect all the original signed signatory pages, compile them with the main text of the Second DAOA Amendment and provide each of the Parties one (1) original of the main text of the Second DAOA Amendment with the original signed signatory pages, which constitutes valid proof of the main text of the Second DAOA Amendment. The foregoing will not impact the date of entry into force of the Second DAOA Amendment; and
- ii) expressly derogating to Article 8.20 of the New Belgian Civil Code, each Party shall receive a zipfile from the third coordinating Party bearing the label "Second DAOA Amendment with Annexes",

3.3 OTE has a national legal obligation within the meaning of Section 2 (1) of the Czech Act No. 340/2015 Coll., on special conditions for the entry into force of certain contracts, the contract publishing and on the National Contract Registry of the Czech Republic according to which this Second DAOA Amendment shall only come into force in relation to the rights and obligations of OTE subject to its prior publication of the Second DAOA Amendment in the National Contract Registry of the Czech Republic. All Parties hereby acknowledge this formality for OTE and accept that the validity of this Second DAOA Amendment for OTE is subject to the abovementioned publication (it being understood that the validity between the other Parties remains unaffected by this condition). OTE commits to comply with this formality without delay and to inform all Parties, without any delay, of the fulfilment thereof.

No Confidential Information shall be disclosed during the course of complying with such obligation, including by redacting all such Confidential Information from any materials or documents

3.4 For the avoidance of doubt, Article 26 (Dispute resolution) and all relevant provisions of Article 27 (Miscellaneous) of the DAOA shall apply to this Second DAOA Amendment.
