1. INTRODUCTIN

Requested services

Institute of Biostatistics and Analyses, Masaryk University Brno, (hereinafter "IBA MU") agreed to provide services specified bellow to AOP Orphan Pharmaceuticals AG (hereinafter AOP) during period between 01. 09. 2016 and 30. 6. 2017 in conjunction with the following project:

"Registr pacientů s dg. Esenciální trombocytémie a trombocytémie provázející jiné myeloproliferativní onemocnění léčených Thromboreductinem®"

Requested services:

- Assistance with project administration and management (includes necessary phone calls, emails and meetings with AOP representatives, necessary communication with database provider).
- Query management
- Pharmacovigilance
- Administration of investigator fee payments which includes:
 - Sending a letter to participating doctors explaining the change of provider
 - Arranging contracts with all participating doctors
 - Annual payment of investigator fees (including bank transfer fees)
 - Management of contact details database and its quarterly update
- Data validation = forms and data check, generation of queries and liaison with the centre, collection of missing data,
- Digitalization of approximately 1200 forms.
- Statistical analysis 1x per year
 - Core statistical analysis (approx. 90 hours)
 - Additional analysis **could be invoiced separately**
 - Analytical support for Principal investigators (prof. Penka and Schwarz)
 - Analysis for publication in an international scientific magazine with an impact factor.
