The following shall be deemed incorporated in and made part of the Agreement to which it is attached.

A. PAYMENTS AND TICKETS

1. All payments by the Purchaser to the Artist must be made by cash or direct transfer prior to the performance.
3. Purchaser shall provide Artist with 5 complimentary tickets per show upon request. Members of supporting media (press, TV, and radio) shall also be admitted free of charge.
4. No portion of the performance hereunder may be photographed, broadcast, recorded, filmed, taped, or embodied in any form of reproducing such performance and Purchaser agrees that it will not authorize any such recording without prior verbal or written consent of the Artist. Purchaser will deny entrance to any person(s) carrying tape or video recording equipment (except artist-authorized). Without limiting in any way the generality of the foregoing prohibition, it is understood to include members of the audience, press, and Purchaser's staff. The artist agrees to photograph the production for the Purchaser's promotional purposes.

B. EQUIPMENT

Purchaser shall provide the following equipment at no cost to Artist:

1. Two (2) sturdy ordinary armless chairs with equal height.
2. Tuned grand piano
3. PA system depending on the size of the hall

C. SOUND SYSTEM

A house electrician and engineer must be available throughout the entire sound check.

D. STAGE HANDS

Minimums of one stagehand is required for load-in and load-out.

E. DRESSING ROOM

One large dressing room with bathroom for the sole use of the Artist. Dressing room must have lock and key and be accessible to artist from load-in to load-out.

F. FOOD

1. The following shall be provided in Artist dressing room at time of load-in:
 - a. Bottled water, hot black tea, and coffee with real milk, sugar, lemon and honey
 - b. Two clean towels

c. A tray of fresh fruits, croissants, vegetables and dip, nuts and cheeses.

2. Following sound check, a healthy, hot meal for two (2).

G. SECURITY

The Purchaser agrees to provide proper and sufficient security at all times to insure the safety of the Artist's equipment while it is in the venue. Security must also be provided at the dressing rooms.

H. BILLING

1. Billing on all advertising and publicity for this performance shall be as follows: Rudy Linka/Bobo Stenson Duo.

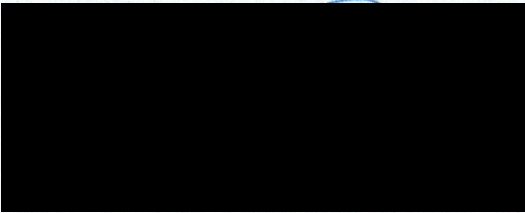
K. MERCHANDISE
