

## AGREEMENT ON FESTIVAL PERFORMANCES

### THE PARTIES TO THE AGREEMENT

The performer declares to be in a position to produce the artistic performances:

for which it assures the participation of the artists and the other necessary staff.

The festival declares to have at its disposal the venue of the performance:

THIS BEING STATED, AND THE FOLLOWING IS DECIDED AND AGREED UPON:

### **1. THE TIME OF THE PERFORMANCE**

The Performer brings to the festival the above mentioned performances that will take place:

**LOG LEG: on Sunday 18<sup>th</sup> of September 2022 at 17.00 pm**

### **2. THE PERFORMER'S BONDS**

The Performer will have the artistic responsibility of the enterprise and it will pay the salaries or the fees for the members of the visiting group for this specific occasion. The Festival makes **agreements only with organisations not with private persons**: the Festival does not have to pay any social security costs etc.

The Festival will pay the tax at the source of income. This tax concerns only performing groups from outside of Finland and it is 15 % of the gross fee of the performance. The Festival pays the tax to the Finnish tax administration.

The Performer will provide the necessary costumes and accessories (unless otherwise indicated under "additional clauses") as well as necessary elements in advertising for the Festival, such as: photos, posters, synopsis of the performance, press clips etc. The Performer gives the rights to produce marketing and press material from these elements.

Specifications:

The Performer will take all the necessary insurances for the members of his group as well as for his materials.

The Performer also assures to have all the rights to use the elements of the performance such as music, script, etc. (for example Teosto, Gramex or any other copy right payments). The Performer will take care of such **payments if not otherwise agreed**.

### **3. THE FESTIVAL'S BONDS**

The Festival declares to have an exact knowledge of the technical and logistic requirements of the performance under the present agreement. The Performer has given the information needed beforehand or is requested to give it immediately.

The Festival will have at the performers disposal the staff and rooms as agreed by the technical description of the production and pay costs of these arrangements.

#### **4. COSTS AND PAYMENTS OF THE PERFORMANCE**

##### **4.1. The Fee**

For performing in the MUKAMAS 2022 - International Puppet Theatre Festival the Performer will charge only for the payments summarised in additional clauses.

##### **4.2. Transportation Expenses and Visas**

The Festival will cover the travelling and freight costs. The costs of transportation are based on receipts. Any other costs will be discussed and agreed separately.

##### **4.3. Accommodation and Per-diems**

The Festival will arrange and pay the hotel accommodation as follows:

Per-diems: 45€ /day /person will be paid for 2 persons 6 days, in total of 540 €.

Time: 17.9.2022 – 19.9.2022

Rooms: 1 x single

Per-diems: 45€ /day /person will be paid for 1 persons 3 days, in total of 135 €.

Time:

17.9.2022 – 19.9.2022

Rooms: 1 x double

Per-diems: 45€ /day /person will be paid for 2 persons 3 days, in total of 270 €.

#### **5. ADDITIONAL CLAUSES**

##### **5.1. Press and Media**

The recording in film or video can be done when used on the news- basis, as reporting of the event but when it is to be shown, broadcasted or commercialised any other way that will be agreed upon independently of the present agreement.

For press meetings during the festival the performer could bring the following information about the performances: shows summary in English or Finnish (including the date of premier and other information needed in the common festival hand book), three photos of the performance(s), curriculum of the

company and the staff involved. Most of the press material is delivered before the festival.

## 6. TERMINATION

The present agreement cannot be broken without penalty from either party, except in the case of indisputable Force Majeure circumstances. Any litigation will be dealt with the Court of Tampere.
