FIBA shall grant to CTV the following exclusive TV rights in the Licensed Territory:

• The right to broadcast the Competition Games in the Licensed Territory by Free Analogue and/or Digital Terrestrial and/or Cable and/or Satellite Television

Notwithstanding the foregoing, CTV acknowledges that all other rights including, but not limited to, radio, internet, video, DVD, clips and archive, etc, shall remain the exclusive property of FIBA.

Consideration

CTV shall pay to FIBA the following Consideration:

a total of five thousand Euros

All payments by CTV to FIBA shall be inclusive of technical costs but exclusive of value added tax and free and clear and without deductions based on any currency control restrictions, import duties, or any sales, use, value added or other taxes or withholdings or bank charges.

FIBA acknowledges that it is the beneficial owner of the fee. Timely payment is conditioned upon receipt of the valid confirmation of the Swiss residency of the FIBA issued by the appropriate Tax Authority of the Swiss Confederation unless such valid confirmation has already been provided to the CTV during the applicable year.

Confidentiality:

In relation to Czech public law - Act on Registration of Contracts (Act No. 340/2015 Coll.) the parties hereby agree that this Agreement shall be published in the Register of Contracts open for free remote Internet access by the general public. The parties have highlighted (in yellow colour) textual parts of this Agreement that shall be unreadable for the purpose of publication in the Register of Contracts since such parts include trade secrets (particularly but not only) and each party takes appropriate measures to keep such parts confidential. The parties agree that the rest of this Agreement (text that has not been marked in yellow colour) shall not be deemed as confidential according to this Agreement.

Miscellaneous:

Other conditions of the use and grant of the TV rights not stipulated in this term sheet shall be the subject of a supplementary Agreement, signed by both Parties.

The terms of this Agreement shall be legally binding.

The interpretation, construction and effect of this Agreement shall be governed in all respects by the Laws of Switzerland.

The language of the arbitration will be English. Any decision of the Court of Arbitration for Sport shall be final and binding on the parties.
