Amendment No. 1 to Partnership Agreement for the implementation of the Project

in Virtual Learning and Teaching Spaces”** under the Erasmus+ Programme, Key
Action 2: Strategic Partnerships.

Article 1

In the Partnership agreement will be changed **Article 5 – Financing, point 5.1**

5.1. The total costs to be committed by the Partner for the period covered by the
Project is estimated at **64 070,00** EUR. Estimated partner budget as specified in
Annex I of this Amendment.

Article 2

1. Amendment No. 1 shall enter into force on the date of signature by the last of the Contracting Parties and take effect after publication in the Register of contracts. It closes by the end of the planned duration of the project, ie 28 February 2023.
2. Any changes or additions to this Amendment No. 1 may only be made in the form of a written change, signed by authorized representatives of both parties.
3. The other Articles of the Partnership Agreement which are not directly affected by this Amendment No. 1 remain unchanged.
4. The Contracting Parties confirm that this Amendment No. 1 was concluded freely, at the will of both parties. Both parties have read its contents, understood it and agree with it, to which they attach electronic signatures of authorized representatives.

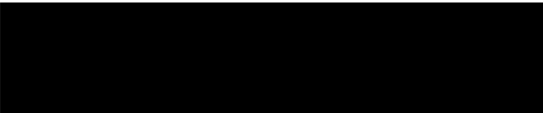
