CONDITIONS

ARTICLE 1 – PURPOSE OF THE CONTRACT

1.1 The sending institution will provide Community financial support to the participant for undertaking a Training Placement under the KA121 – mobility in vocational education and training of the Erasmus+ Programme and will pay for the services indicated in this contract to the host institution.

Project number: 2022-1-CZ01-KA121-VET-000059687.

1.2 The host institution undertakes to carry the services referred to in this Agreement in the **Article 4 – Payment Arrangements** in accordance with **Erasmus+ learning agreement complement**.

ARTICLE 2 – DURATION

2.1 The contract shall enter into force on the date when the last of the two parties signs.

2.2 The preparatory visit shall start in October 2022.

2.3 The Training Placement shall start on 06th November 2022. The total number of days spent in Braga will be 21.

ARTICLE 3 – FINANCING THE TRAINING PLACEMENT

3.1 For the placement governed by this Agreement, the sending institution undertakes to finance mobility expenditure in accordance with the financing rules established by the Erasmus+ National Agency.

ARTICLE 4 – PAYMENT ARRANGEMENTS AND SERVICES

4.1 The sending institution undertakes to pay to the hosting institution the total amount of € 13115 to arrange the following services regarding the training placement for 10 interns (that is € 12050) + 2 teacher (that is €450) and preparatory Visit 2 teacher (that is € 615)

- 21-day full Board Accommodation at the 3-star hotel for the students
- 5-day full Board accommodation at the 3-star hotel in single room for 2 the teachers
- 4-day half board accommodation at 3-star hotel for 2 teachers preparatory visit
- arrangement of the Work Programme according to the Learning agreement

- issuing of the Europass Mobility certificates and completion of Learning agreement complement
- working hours for the interns – 6 hours per day / 5 days a week
- monitoring of the Work Programme
- airport transfer from Porto to Braga
- administrative cost
- cultural program
- local travel pass for 21 days for the interns
- local travel pass for 5 days for 2 teachers
- local travel pass for 4 days for 2 teachers
- sending information about Work Programme, Work Placements and accommodation for each intern three weeks prior scheduled arrival at the latest

4.2 The sending institution undertakes to pay as follows:

1. payment: € 615 until (date) 18.10.2022
2. payment: € 10000 until (date) 02.11.2022
3. payment € 2500 until (date) 23.11.2022
