

Addendum to Memorandum
between
PALACKY UNIVERSITY OLOMOUC
and
UNIVERSITY OF NEBRASKA AT KEARNEY
Increasing Institutional Collaboration

On the basis of the existing Memorandum of Understanding between University of Nebraska at Kearney (UNK) and Palacký University Olomouc (UP) signed on the 20th of April 2022 both universities have expressed interest in strengthening the partnership.

The goals of the partnership are to:

- Increase the number of students from each institution who live and study (study abroad) at the partner institution; AND
- Begin exchanges of faculty and staff to support scholarship, curricular development, and administrative enrichment; AND
- Facilitate collaboration between various constituent components in each university.

To foster growth in these and other areas, it is agreed by the two institutions that each university will appoint an employee to identify and assess collaboration opportunities, support the development of specific projects between the two institutions, and monitor project results. Each person will be formally known as an External Advisor to the counterpart University.

UNK's designated employee shall be:

UP's designated employee shall be:

Palacky University Olomouc

[REDACTED] will consult with UP staff and faculty throughout the year and make an annual visit to Olomouc lasting two to three weeks as appropriate. [REDACTED] will be responsible for reporting his work to [REDACTED] and [REDACTED] at Palacky and to [REDACTED] [REDACTED] at UNK.

[REDACTED] will consult with UNK staff and faculty throughout the year and make an annual visit to Kearney lasting two to three weeks as appropriate. [REDACTED] will report to [REDACTED] [REDACTED] and [REDACTED] at UNK and to [REDACTED] at Palacky University.

In consideration of his expertise and services, UNK will pay a stipend of \$1,000 (one thousand dollars) to [REDACTED] in the academic year 2022/2023.

In consideration of her expertise and services, UP will pay an equivalent of \$1,000 in Czech crowns to [REDACTED] in the academic year 2022/2023.

Each institution will pay travel expenses for the External Advisor to visit their university: UNK will pay for [REDACTED] and UP will pay for [REDACTED]. Expenses will include air transportation and lodging.

This agreement continue until 31st of August 2023. It may be renewed by mutual agreement. This Addendum may be renewed by written amendments on one deed hereto.

Either party to this Addendum may terminate this Addendum by giving 30 days written notice. The period of notice shall commence upon delivery of the notice to the designated employee. During that

30 days further expenditures shall cease, and each party shall settle up with the other on already incurred expenses.

The parties hereto acknowledge the fact that this agreement is subject to obligatory publication under the Czech Act No. 340/2015 Coll. On Special Conditions of Effect of certain Contracts, Publication of these Contracts and on the Register of Contract (Act on the Register of Contracts). The parties take note that this contract enters into effect at the moment of its publication in the register of contracts. Palacky University Olomouc, who shall ensure publication of the contract in the register of contracts, shall inform [REDACTED] of its publication. The contractual parties undertake to refrain from provision of whatever performance herunder prior to its effective date.

On behalf of their institutions, each principal's signature below made this 26th day of October, 2022 indicates acceptance and agreement to this Memorandum of Understanding.
