CONDITIONS

ARTICLE 1 – PURPOSE OF THE CONTRACT

- 1.1 The sending institution will provide Community financial support to the participant for undertaking a Training Placement under the KA 1 – mobility in VET of the Erasmus + Programme and will pay for the services indicated in this contract to the host institution. Project number: 2021-1-CZ01-KA122-VET-000017275
- 1.2 The host institution undertakes to carry out the services referred to in this Agreement in the Article 4 Payment Arrangements in accordance with Erasmus + VET Mobility Quality Commitment

ARTICLE 2 – DURATION

- 2.1 The contract shall enter into force on the date when the last of the two parties signs.
- 2.2 The Training Placement shall start on 29. May 2023 and end on 16. June in case there will be lifted COVID-19 restrictions preventing smooth arrangement of the internships and international transport. Exact term of the mobility will be specified by sending institution till the end of February 2023. Anyway the total number of days spent in Malta will be 21

ARTICLE 3 - FINANCING THE TRAINING PLACEMENT

- 3.1 For the placement governed by this Agreement, the sending institution undertakes to finance mobility expenditure in accordance with the financing rules established by the Erasmus + National Agency.

ARTICLE 4 – PAYMENT ARRANGEMENTS AND SERVICES

- 4.1 The sending institution undertakes to pay to the hosting organisation the total amount of **6465,10 euro** to arrange following services regarding the training placement for 8 learners (that is 782,42 euro per 1 participant) and 1 teacher (that is 205,74 euro):
- 21 days accommodation in self catering residence for learners (17,12 euro * 21 days = 359,52 euro per head)
 - 7 days accommodation in a single room in the same self catering residence for learners for the teacher (21.40 euro * 7 days = 149.80 euro)
 - arrangement of the Work Programme (practical training in the companies) according to the ECVET standards with focus on business administration, accounting or office IT, issuing of the Europass certificates and completion ECVET documents, monitoring of the Work Programme, sending information about Work Programme and host families for each learner one week prior scheduled arrival at the latest (295 euro per one learner)
 - local travel pass for 21 days for learners (63 euro per head)
 - local travel pass for 7 days for the teacher (21 euro per head)
 - airport transfer for both learner and the teacher – both ways (23,60 per head)
 - full days excursion to Gozo for both learners and the teacher (41,30 per head)
 - sending information about Work Programme and self catering accommodation for each learner one week prior scheduled arrival at the latest
- 4.2 The sending institution undertakes to pay as follows:
2586 euro (40%) on confirmation of the group and the dates, 2576 euro (40%) on submission of the work placement list and accommodation list and 1293,10 euro (20%) one week before arrival in Malta
