THE SERVICES SET FORTH IN THIS STATEMENT OF WORK (“SOW”) dated as of _____ (the “**SOW Effective Date**”) shall be performed pursuant to the terms and conditions of that certain Master Services Agreement, dated as of June 15, 2022, by and between **Nurix Therapeutics, Inc.** (“**Nurix**”) and **Mikrobiologický ústav AV ČR, v. v. i.** (“**Company**”) (the “**Agreement**”).

- 1. - 2. Deliverables.** Company shall provide all reports and other agreed-upon deliverables to be rendered in connection with the Services (collectively, the “**Deliverables**”), in a format mutually agreed to by both Parties. For clarity, Deliverables shall include, without limitation, analysis reports, data, heat maps, and completed structures.
- 3. Timelines.** All Services and Deliverables shall be provided in accordance with the timelines set forth in Attachment A, or if no timelines are included in Attachment A, as agreed to by the Parties.
- 4. Term.** Unless terminated earlier as provided in the Agreement, the term of this SOW shall begin on the SOW Effective Date and continue until the earlier of the completion of the Services or one (1) year following the SOW Effective Date.
- 5. Invoicing and Payments.** Company shall invoice Nurix for payment according to the estimated costs and payment schedules set forth in Attachment A. Payment shall be made within thirty (30) days of Nurix’s receipt of a Valid Invoice sent by Company. A “**Valid**
