

LETTER OF GUARANTEE

Your signatures on the Demand must be verified by your bank confirming that the signatures are authentic and legally binding on the Beneficiary.

The Guaranteed Amount shall be decreased by every payment from this guarantee made by us. This guarantee shall terminate after the whole Guaranteed Amount has been paid out.

This guarantee is effective until 31 May 2019 inclusive (the "Expiry date"). This guarantee expires by lapse of the Expiry date regardless whether the Expiry date is a business day or not at the place for presentation of the Demand.

This guarantee shall also terminate by lapse of the day when the original of this guarantee is returned to us, if such return occurs prior to the Expiry date.

This guarantee is not transferable. Proceeds ensuing from this guarantee cannot be assigned or pledged.
