I.

The Consultant and the Client have concluded a Contract for providing basic drilling and evaluation EGS concept for the feasibility study of the SYNERGYS project on 15. 09. 2022 (hereinafter Contract).

II.

By this Amendment, the Parties amend the Contract as follows:

2.1 Article 2.1 of the Contract shall be amended to read as follows:

“Consultant undertakes to prepare and hand over the written proposal in structure in accordance with article 1.2.1. of this Contract to the Client within the following deadlines:

a) first draft of the EGS well design concept no later than 25 days from the date the Contract becomes effective, electronically by e-mail (see contact for technical issues above)
b) final version of the EGS well design concept no later than on 31st of January 2023, electronically by e-mail (see contact for technical issues above) incl. digital signature (in case the Consultant has not a digital signature available, a signed hard copy will be sent to the Client’s address (see above) along with the electronical version.”

2.2 Article 5.2 of the Contract shall be amended to read as follows:

“The Contract terminates by 31st of January 2023.”

2.3 All other terms and conditions of the Contract shall remain unchanged.
