DONATION OF PERSONAL PROPERTY AGREEMENT

under Section 2055 et seq. of Act No. 89/2012 Coll., Civil Code, as amended

- 1. Donor hereby donates to Donee, and Donee hereby accepts, the equipment identified in the table set forth in the attached Exhibit, which is incorporated into this Donation of Personal Property Agreement by this reference ("Equipment").
- 2. Donor represents that title in and to the Equipment is free and clear of liens and encumbrances. In all other respects, Donor donates the Equipment to Donee as is, where is, and with all faults and Donee accepts the Equipment as is, where is, and with all faults. Without limiting the generality of the foregoing, Donor will inform Donee of all Equipment defects known to Donor.
- 3. Donor hereby represents that he did not manufacture the Equipment and the Equipment was never intended for the purpose of sale or distribution to third parties within the business activity of Donor. The donation of the Equipment has no connection, whatsoever with the business activity of Donor.
- 4. The Donor and Donee hereby exclude any warranties for the Equipment or the liability for damages that may occur in connection with the use Equipment due to the defect in Equipment, especially but not limited to the damages according to the section 2056 of Czech Civil Code.
- 5. Donee hereby accepts that no rights to software, operation systems, application or licenses necessary for the operation of Equipment were established by this contract. Donee hereby acknowledges that all software, operation systems, application or licenses to such a system, were uninstalled from the Equipment by Donor.
- 6. In case the Equipment contains any software, operation systems, application or licenses or information installed or uploaded thereto by Donor, the Donee undertakes the obligation to inform the HR Department via email: rm-hrcmczech@intl.att.com without undue delays and to hand over the Equipment so the residual content may be erased.
- 7. Donee will collect the Equipment at the location identified in the table below. When Donee arranges for the collection from Donor's premises, Donee is responsible for ensuring that carriers instructed by Donee and its drivers hold all necessary licenses and are suitably trained.
- 8. Donee represents that it is a registered charitable entity. It warrants that the Equipment will be used only for charitable purposes.
- 9. Donee understands that the Equipment may be subject to product regulations, regulated as hazardous materials or may be subject to other regulations or restrictions imposed on those transporting, distributing, supplying or using the Equipment. Donee will comply with all such regulations or restrictions, including with respect to packaging, labeling, warnings and instructions, technical documentation and storage and shipping method constraints.
- 10. The laws of the Czech Republic govern the interpretation and enforcement of this Agreement.
