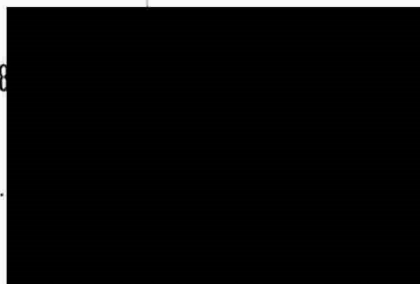
2. Article SUBJECT OF THE AMENDMENT No.1

Part 1: Site Acceptance Test (SAT) not later than: November 30, 2018

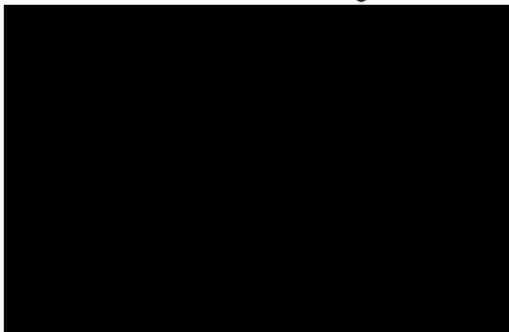
3. Article FINAL PROVISIONS OF THE AMENDMENT No.1

- 3.2 **This Amendment has been signed** by ANS CR and the INDRA NAVIA AS by their duly authorized representatives in four (4) original copies, in English of which each of the Parties shall receive two (2) copies.
- 3.3 Personal Data Protection.
