on the second part,

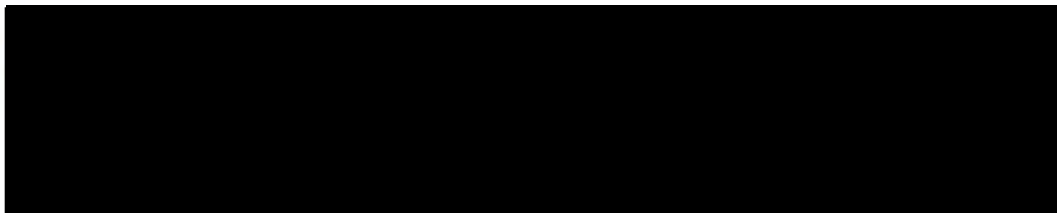
NOW THEREFORE THE PARTIES HAVE AGREED AS FOLLOWS:

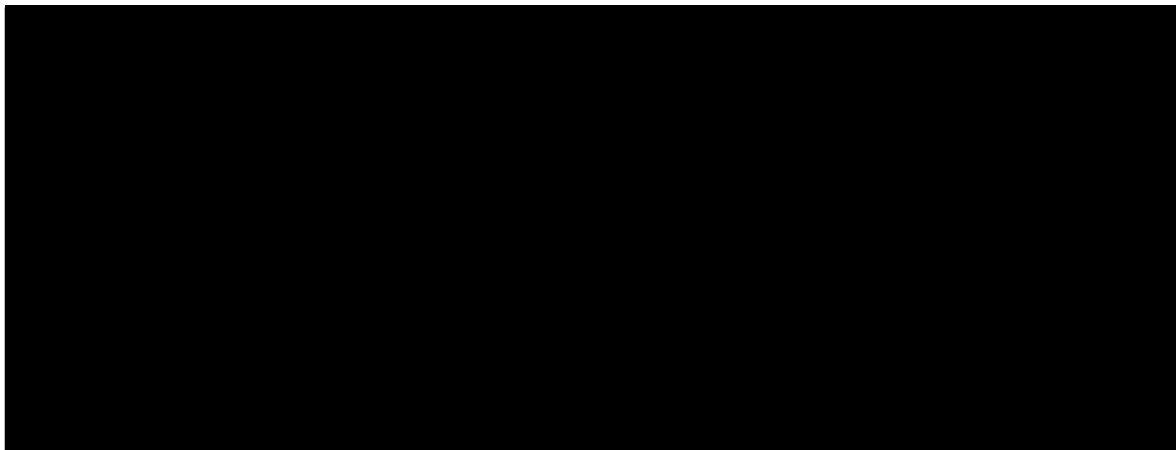

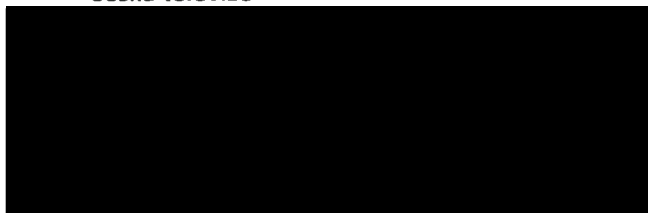

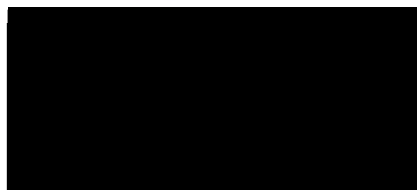
