The Parties hereby agree as follows:

### **1. Subject-matter of the Agreement**

- 1.1. GTK shall perform work consisting of the organization of face-to-face UNFC (United Nations Framework Classification) training course in Czech Republic for the Customer (hereinafter "course").
- 1.2. The Customer agrees to pay to GTK the price for it in line with the terms and conditions stipulated herein.

### **2. Performance of Work**

2.1 In this Agreement the Work is defined as follows:

GTK experts will organize face-to-face UNFC course in Czech Republic. The course will be designed to cover the basics on the UNFC classification and how it can be applied from project inventories to harmonizing tool for national reporting. The course will include case-study examples and practical exercises (homework/group assignments) from Finland and other European countries (e.g. Mintell4EU) and will demonstrate the GTK's approach and current status in regards to the UNFC.

The course will have a brief introduction to resource estimations and uncertainties involved in the mineral resource inventories. GTK will also cover CRIRSCO International Reporting Template used by the industry for reporting and disclosure of exploration results, mineral resources and reserves.

The course exercises may also be based on data and information provided by the Czech Geological Survey ("Customer"). The course contents and details are agreed with the customer. The final course agenda, the possible pre-course exercise, and presentations will be shared with the participants one (1) week before the face-to-face course.

2.2 Any additional work will be agreed separately in accordance with the unit prices.

2.3 Schedule

- 2.3.1 Background material shall be agreed and received from the customer one (1) month before face-to-face course.
- 2.3.2 UNFC Course preparations shall take five (5) working days in Finland.
- 2.3.3 The final course agenda, possible pre-course exercise and presentation will be shared with the participants one (1) week before face-to-face course.
- 2.3.4 Three (3) days face-to-face course in the Czech Republic is scheduled in March 2023. The final schedule will be agreed upon together with the customer.

2.4 In case of injury or sick leave, GTK does not offer any replacement geologist (or other expert) for this project. New time for course will be agreed between GTK and the customer.

2.5 All project information is considered confidential. The Customer agrees that GTK may use this course as a reference and in such context state [GTK has held a UNFC training course (date) for the Czech Geological Survey in Czech Republic] but without revealing any confidential information.

2.6 Background material agreed and received from the customer one (1) month before the face-to-face course. Any background material received after this time limit, also during the face-to-face UNFC course, is not accepted as part of the course content.

**3. Price for Work**

3.1 Daily pricing will be applied (VAT 0%):

The daily prices include all employee costs (salaries, daily allowances, etc.).

3.2 Travel, accommodation, and other costs related to the work will be invoiced based on actual costs.

The GTK will provide the typical tools and equipment, but if any special supplies are needed for the work, the costs will also be added to the invoice following an agreement with the customer.
