



**FIRST AMENDMENT  
TO THE INTER-INSTITUTIONAL AGREEMENT**

This First Amendment to the Inter-Institutional Agreement (“**First Amendment**”), effective as of the date of last signature, is entered into by and between the Institute of Organic Chemistry and Biochemistry of the Czech Academy of Sciences (Ústav organické chemie a biochemie AV ČR, v.v.i.) (“**Institution**”), and the Johns Hopkins University (“**JHU**”). Institution and JHU may be referred to herein individually as a “Party” and collectively as the “Parties.”

**RECITALS**

**WHEREAS**, the Parties previously entered into the Inter-Institutional Agreement internally referenced by JHU as [REDACTED] made effective as of 23 September 2020, and which covers the jointly-owned invention entitled [REDACTED] (the “Original Agreement”);

**WHEREAS**, the Original Agreement named JHU as the lead institution, wherein JHU was designated as the lead party in all patent prosecution and commercialization efforts; and

**WHEREAS**, the Parties now wish to amend the Original Agreement to reflect a newly-agreed share in the respective expenses and revenue generated by the [REDACTED];

**NOW, THEREFORE**, the Parties hereby agree as follows:

1. **The Second Paragraph of the Recitals (“WITNESSETH THAT:”)**. The Second Paragraph of the Recitals Section (“WITNESSETH THAT:”) of the Original Agreement, assigning the respective ownership shares of the Parties, shall be deleted in its entirety and replaced with the following:

WHEREAS, INVENTORS’ rights to said INVENTION have been assigned jointly to the respective Parties, with JHU having [REDACTED] interest in said INVENTION, and INSTITUTION having [REDACTED] interest in said INVENTIONS (respectively, hereinafter referred to as PARTY’S INTEREST). The “PARTY’S INTEREST”, for the purpose of this AGREEMENT, shall mean [REDACTED]

2. **Section 3**. Section 3 of the Original Agreement, apportioning the [REDACTED], shall be deleted in its entirety and replaced with the following:

- 4. The Parties agree that all capitalized terms used in this First Amendment but not otherwise defined herein shall have the meaning set forth in the Original Agreement.
