#### 1. GENERAL SAFETY PRECAUTIONS

- The organizing STIHL subsidiary is responsible for compliance with the safety measures on the corresponding event (competition, training camp, media event, etc.). In case the organization handed over to another company, service provider or agency, it is in the responsibility of the STIHL subsidiary to give the needed briefings.
- Each type of event needs an individual risk assessment to define and eliminate any type of dangers.
- Stands for the exercising of the sport need have enough space from walls, fences, nets or similar to secure a safe performance of the discipline.
- All type of Tools (for sport and setup) need to be out of the danger zone, where athletes are exercising the sport.
- Tools (especially axes and saws) that are not in use must always be covered or stowed away in a corresponding box/place.
- Non-essential staff and athletes must remain outside established safety distances during active set-up and change over periods.
- Each person present must wear protective clothing (e.g. cut-resistant trousers, ear protectors, etc.) appropriate to their work/activity.
- In case of the execution of Stock Saw and/or Hot Saw or use of any other chainsaw, all participants must have hearing protection available to them for the duration of the activity.
- All involved persons (including athletes and assistants/helpers) need to be aware of the dangers of this sport.
- Always follow the STIHL TIMBERSPORTS® Rules and Regulations
- Warn each other in case of danger.

#### 3. INSURANCE

Please make sure to register the event (**any** competition, training camp, show, wood preparation and media event (also by third parties like TV show productions, athlete interviews, press conferences, etc.)) at the official TIMBERSPORTS® insurance (FUNK) by using the official form. Insured sums: 65,000€ for death and 130,000€ for full disability.

Additional insurance benefits must be requested individually by the athletes / organization themselves. Inform the athletes about this fact.

### 4. SAFETY DISTANCES


All distances are **minimum requirements** for any TIMBERSPORTS® event (competition, training camp, show, wood preparation and media event (also by third parties like TV show productions, athlete interviews, press conferences, etc.)).


## Standing Block, Underhand and Springboard

- 4.8 meters (15.7 feet) minimum safety distance to the middle of the next stand (if athletes compete on stands next to each other
- 9 meters (29 feet) minimum safety distance to audience and timers (from middle of the stands)

# Sawing disciplines

- 5 meters (16.4 feet) minimum safety distance to the middle of next stand (if athlete compete on stands next to each other)
- 9 meters (29 feet) minimum distance to audience and timers (from the middle of the stands)
- Safety shields for hot saw during technical check and competition (back and front of saw)





# 5. MEDICAL COVERAGE

Make sure that an appropriate emergency medical care is available at each and every event (**any** competition, training camp, show, wood preparation and media event (also by third parties like TV show productions, athlete interviews, press conferences, etc.)).

In case of an accident we need to ensure quick and appropriate medical care. The emergency escape route has always to be kept free. If you have audience on site, an ambulance is advisable.









## 6. BRIEFINGS

All people on stage, in particular all members of the stage and film / photo crew, which according to the impression of the undersigned was complete, about all potential safety risks and how to act on stage, in particular during a competition.
