Termination of Collaboration Agreement

concluded on 01/02/2023 in Prague, Czech Republic, by and between:

(hereinafter called “the Contractor” or “Iguassu”),

and:

North-Bohemian Observatory and Planetarium in Teplice

(official name “Severočeská hvězdárna a planetárium v Teplicích, příspěvková organizace”, hereinafter called “the Subcontractor” or “Teplice Observatory”),

whose Registered Office is at:

represented by: Mr Zdeněk Moravec, its director,

of the other part,

jointly referred to as the Parties or each of them as the Party, the Parties agree as follows:

§1 [Statements]

1. The Parties jointly confirm that they have concluded the Cooperation Agreement (hereinafter: the Cooperation Agreement), dated as of 26th January of 2022.
2. The Parties jointly confirm that in connection with conclusion of the Cooperation Agreement, Iguassu paid to Teplice Observatory an advanced payment in the amount of EUR 3,500.
3. Teplice Observatory states that the advanced payment will be used for services specified in the Collaboration Agreement between Sybilla Technologies (hereinafter: Sybilla) and Teplice Observatory.
4. Therefore, total costs borne by Teplice Observatory to Iguassu amounts to EUR 0.
5. The Parties confirm that they wish to terminate the cooperation based on the Cooperation Agreement.

§2 [Termination of the Cooperation Agreement]

1. The Parties jointly terminate the Cooperation Agreement, with effect from the date of conclusion of this termination agreement.
2. Further performance of the project referred to in the Cooperation Agreement will be conducted by Sybilla and Teplice Observatory without Iguassu involvement.
3. Sybilla is entitled to continue cooperation with the Teplice Observatory, whereas the services will be continued and provided directly to Sybilla. The Parties agree to book the advanced payment paid by Iguassu to the Teplice Observatory for the payment for the continuation of cooperation between Sybilla and the Teplice Observatory. Iguassu shall not demand the Teplice Observatory to return the advanced payment to Iguassu due to the discontinuation of cooperation.

§3 [Settlement]

1. Teplice shall not return any part of the advanced payment to Iguassu.
2. The Parties jointly indicate that the settlement referred to above constitutes a comprehensive settlement of cooperation based on the Cooperation Agreement and the Parties have no other claims against each other for remuneration, reimbursement of costs or advance payments.

§4 [Final provisions]

1. The Parties agree that all Deliverables (according to the meaning as in the Cooperation Agreement) provided to Sybilla, shall remain in the ownership of Sybilla.
2. The agreement has been drawn up in two identical copies, one for each of the Parties.
