

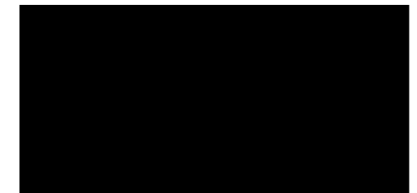

Pricing Metrics and Additional Usage Parameters



- **Academic Institution Department** - The Fee is based on use of the Software by Users and Students of a single Academic Institution Department for Teaching and Research Use. “**Academic Institution Department**” means a single school or college of a DGI that is dedicated to a single subject and is located in the Territory. Where multiple Academic Institution Departments exist within a single school or college, a separate license is required for each Academic Institution Department that uses the Software.
- **Academic Institution License – Teaching and Research Use** - Customer certifies that it is an “**Academic Institution**” defined as either: (i) a post-secondary degree-granting institution (“**DGI**”); (ii) an entity over which a DGI maintains statutory or other legal authority for general budget and contracting rights; or (iii) a kindergarten, primary school or secondary school or a government department or agency that supports or operates such entities (“**K-12**”). If the second certification applies, the DGI may not use the Software and Customer may not use the Software for the benefit of the DGI. Customer agrees to immediately notify SAS in writing of any change to Customer’s certification. Such change may result in additional Fees based upon SAS’ then current commercial Fees for the Software and may require that Customer acquire a new license for the Software.
- Users include Customer’s faculty members, staff and Students. “Students” means students registered with Customer to take classes on campus or via the Internet. Users may use the Software (a) only in conjunction with classroom instruction and coursework directly related to Customer’s post-secondary degree requirements, including the formulation of theses and dissertations, and for Customer’s noncommercial research activities if Customer is a DGI or (b) only for classroom instruction if Customer is a K-12 (collectively, “**Teaching and Research Use**”).
- Customer may distribute personal computer Software to Users using Customer’s internal distribution process. Customer may recover from Students Customer’s actual administrative costs of distribution. For personal computer Software, Authorized Environments may be controlled by Users.
- If the pricing metric is Professor License, Customer may install the Software on any number of Authorized Environments running a single SAS-supported operating system. With the exception of Professor Licenses, when licensing SAS 9.x Software for Teaching and Research Use, Customer may install the Software on any quantity of Authorized Environments and use the Software with any or all SAS-supported Windows-based operating systems and with up to two (2) additional SAS-supported operating systems as identified in the Order Form or subsequently requested by Customer in writing. Customer may, upon written request, exchange the Software designed for use with one (1) of the two (2) non-Windows-based operating systems with a copy of the Software designed for use with another SAS-supported operating system and such exchange will become effective as of the beginning of the next annual License Period provided, however, that no such exchange is permitted after SAS has provided a full-term Product Authorization Code for the applicable License Period.
- With the exception of Professor licenses, when licensing non-SAS 9.x Software for Teaching and Research Use, Customer may install the Software on any quantity of Authorized Environments running any or all SAS-supported operating systems.
- **Enterprise Use** - For this Order Form, the Territory is global. Users may use the Offering for the benefit of Customer and its Related Entities. Unless the Pricing Metric is based on the processing capacity of the Authorized Environment, the Pricing Metric quantity is determined by combining the quantity associated with Customer and its Related Entities benefitting from the use of the Offering. If Customer expands the use of the Offering to benefit additional Related Entities, Customer will notify SAS of any increase to the Pricing Metric quantity and pay any applicable additional Fees. If the Pricing Metric is based on the processing capacity of the Authorized Environment, the Pricing Metric quantity is calculated separately for each Authorized Environment used for production purposes based on the processing capacity of the Authorized Environment.

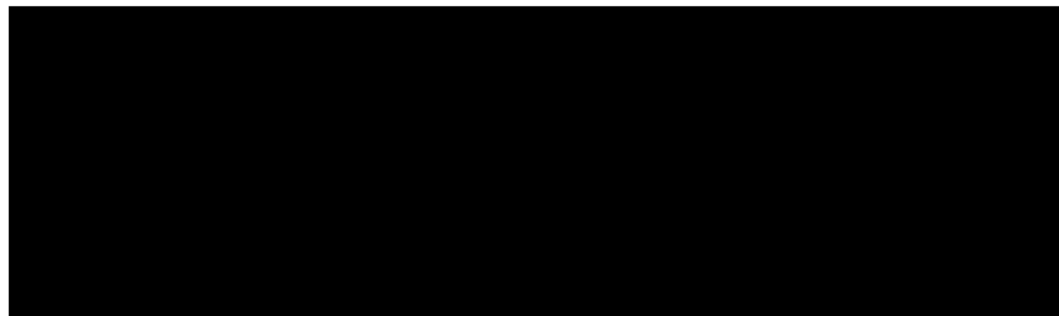
