## Multilateral Inter-Institutional Agreement for BIP

(Project: "Membranes for water resources: treatment, recovery and recycle")

#### **Key Action 1**

Learning Mobility for Higher Education Students and Staff among EU Member States and third countries associated to the Programme <sup>1</sup>

The institutions agree to cooperate for the exchange of students and/or staff in the context of the Erasmus+ programme. They commit to respect the quality requirements of the Erasmus Charter for Higher Education in all aspects related to the organisation and management of the mobility, including automatic recognition of the credits awarded to students by the partner institution as agreed in the Learning Agreement and confirmed in the Transcript of Records, or according to the learning outcomes of the modules completed abroad, as described in the Course Catalogue, in line with the European Credit Transfer and Accumulation System. By checking this box, the partners confirm that they are willing to exchange students who wish to carry out their mobility in a blended format, a combination of a short-term physical mobility with a virtual component.

### **B.1** Further specifications of the mobility

- The partner institutions commit to send the above mentioned amount of students with Erasmus Grant, to the receiving institution.
- · The selection of the students will be done by the sending institution.
- A minimum of 15 financed students in total (=sum of students coming from both partner institutions) participating in the BIP is necessary for the BIP to be valid.
- Before, during and/or after the physical mobility, "virtual mobilities" (such as online project management meetings, workshops, presentations...) are organized as integral part of the BIPproject.
- After attending the BIP "Validation", participating students will be awarded 3,5 ECTs, through a transcript of records, issued by the receiving institution.

 The receiving institution (= coordinating institution, E GIRONA02) will have 14 own students participating in the BIP "Validation".
